DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age, a citizen of the United States, a resident of the state of Washington, and competent to be a witness.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party and excursion service carriers that may be operating without the required Commission-issued certificate.
3. On June 29, 2021, I mailed a compliance letter to AJ's Wine Tour & Transport LLC, d/b/a AJ's Wine Tours & More LLC, (AJ's Wine Tour or Company) explaining that Commission staff (Staff) believed AJ's Wine Tour was operating as a charter party or excursion service carrier in the state of Washington without the required certificate.¹ The compliance letter explained that to avoid enforcement action by the Commission, AJ's Wine Tour must: (1) remove any advertisement offering charter party or excursion carrier service, (2) stop providing charter party or excursion carrier service; and (3) file a completed application or explain in writing why its operations did not require operating authority by July 14, 2021.
4. On July 7, 2021, the Company received the compliance letter at 1157 SE Date Ave., College Place, Washington, 99324.² AJ's Wine Tour failed to respond to the compliance letter.
5. On August 13, 2021, I contacted AJ's Wine Tour under an assumed name through Facebook Messenger and inquired about the Company's availability for wine tours. On August 14, AJ's Wine Tour responded that it had "some open spots in August" and that "September is pretty open."³

6. On August 23, 2021, I contacted AJ's Wine Tour through Facebook Messenger and requested a quote for a 10-passenger wine tour on September 25, 2021. The Company responded and offered a quote of \$750 for a 10-passenger wine tour and asked for a deposit of \$100 to reserve the date. When I inquired about mailing a check to AJ's Wine Tour for the deposit, the Company responded, "You can make it out to Jose Sanchez I'm the owner. My address is 1157 SE Date Ave. College Place, Washington, 99324."⁴
7. On August 27, 2021, I searched Commission records, which showed that AJ's Wine Tour did not have the required authority to provide charter party or excursion carrier service in the state of Washington.⁵
8. On August 27, 2021, I searched Washington Department of Revenue's (DOR) Business Licensing Service for AJ's Wine Tour, which produced records showing an active account under UBI: 604-398-771; listed 1157 SE Date Ave., College Place, Washington, 99324, as both the location and mailing address; and listed Jose Sanchez Michel as the governing person.⁶
9. On August 27, 2021, I searched Washington Secretary of State's (SOS) database, which produced records showing an active account for AJ's Wine Tour under UBI: 604-398-771; listed 1157 SE Date Ave., College Place, Washington, 99324, as both the street and mailing address; and listed Jose Sanchez Michel as the governor.⁷
10. On August 27, 2021, I visited the Company's Facebook page, www.facebook.com/AJs-Wine-Tour-LLC-2035049523481723. Under the "About" tab on the Company's Facebook page, AJ's Wine Tour provided the phone number of (509) 200-0918 and an address of 1157 SE Date Ave., College Place, Washington, 99324.⁸ Under the "Community" tab on the Company's Facebook page, I observed numerous public posts from AJ's Wine Tour advertising charter party or excursion carrier service.⁹ Under the "Photos" tab, I observed a picture of a black Ford Transit van with license plate BOT6133 that was posted to the Company's Facebook page on September 7, 2019.¹⁰
11. On August 27, 2021, I searched Washington Department of Licensing's (DOL) DRIVES application for vehicle information on the black Ford Transit van with license plate

BOT6133, which produced records showing the motor vehicle is registered to Jose G. Sanchez Michel and Jessica Oliva Flores at 1157 SE Date Ave., College Place, Washington, 99324, and provided VIN: 1FBAX2CM2JKA67753.¹¹

12. On August 27, 2021, I contacted DOL to find out whether AJ's Wine Tour was authorized as a limousine carrier and if the 2018 Ford Transit van with VIN: 1FBAX2CM2JKA67753 was registered as a limousine vehicle.¹² On August 31, DOL notified me that AJ's Wine Tour did not have a limousine license.¹³
13. On October 14, 2021, I searched Commission records, which showed that AJ's Wine Tour did not have the required authority to provide charter party or excursion carrier service in the state of Washington.¹⁴
14. Based on paragraphs 3 through 13 above, Commission staff finds that AJ's Wine Tour operated as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.

RE: Charter and Excursion Service Carrier

Dear Jose G. Sanchez Michel:

The Washington Utilities and Transportation Commission (Commission) believes that you are providing passenger transportation services that require charter and excursion authority from the Commission. To advertise, solicit, offer, or enter into an agreement to provide charter and excursion services without a certificate is illegal and subject to a penalty of up to \$5,000 per violation.

The purpose of this letter is to learn more about your passenger transportation services, help you understand charter and excursion regulations, and direct your company to respond to avoid any potential penalties.

What you need to do

To avoid enforcement action by the Commission, your company must:

- Immediately remove any advertisement offering charter and excursion services;
- Stop providing charter and excursion services; and
- Either submit a completed application (enclosed), file proof of insurance, and include the application fee; or respond in writing by July 14, 2021, explaining your company's operations and why they do not require operating authority from the Commission.

Charter and excursion regulations

The Commission regulates charter and excursion carriers in the state of Washington in the public interest.¹

A charter carrier means every person engaged in the transportation of persons for compensation over any public highway in this state who, pursuant to a common purpose and under a single contract, acquires the use of a motor vehicle to travel together as a group to a specified destination or for a particular itinerary, either agreed upon in advance or modified by the chartered group after leaving the place of origin.²

An excursion carrier means every person engaged in the transportation of persons for compensation over any public highway in this state from points of origin within any city, town, or area, to any other location within the state of Washington and returning to that origin. The service must not pick up or drop off passengers after leaving and before returning to the area of origin. The excursions may be regularly scheduled and compensation for the transportation offered or afforded must be computed, charged, or assessed on an individual fare basis.³


In relation to both charter and excursion carriers, a motor vehicle means every self-propelled vehicle with a manufacturer's seating capacity for eight or more passengers, including the driver, used on the public highways for the transportation of persons for compensation.⁴

Application for charter and excursion authority

To provide charter and excursion service, your company must first apply for charter and excursion authority. Your company cannot operate as a charter and excursion carrier in the state of Washington until the Commission grants you a certificate.

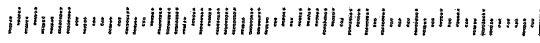

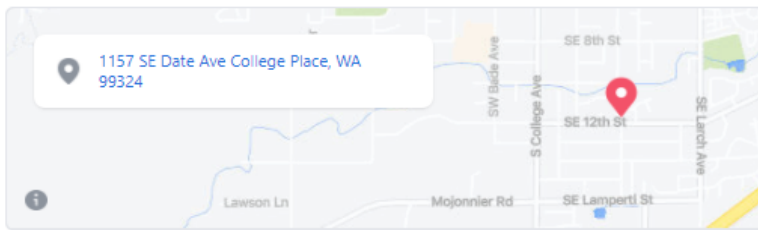

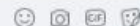
