DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age and competent to testify to the facts contained herein.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party or excursion service carriers that may be operating without the required Commission-issued certificate.
3. On April 12, 2021, the Commission received the application for Northwest Touring LLC d/b/a NW Touring; NW Touring & Concierge; Last Minute Wine Tours; Herding Cats Wine Tours, et al., (Northwest Touring or Company) to provide charter and excursion carrier services in the state of Washington. In the application, Northwest Touring LLC provided the phone number (503) 706-6168; listed UBI: 604-740-505; provided the email address of madsry@gmail.com; listed the physical and mailing address of 520 NE C Street, College Place, Washington, 99324; listed Ryan Madsen as the owner of Northwest Touring LLC; and listed a 15-passenger 2019 Ford Transit 350HD with a “pending” license plate number and vehicle identification number 1FBVU4XM7KKB88215.¹
4. On April 29, 2021, the Commission granted Northwest Touring LLC authority for charter and excursion carrier services in Docket TE-210236.²
5. On May 25, 2021, the Commission notified Northwest Touring LLC that its certificate would be canceled if the Company failed to submit acceptable proof of insurance by June 30, 2021. On July 1, 2021, the Commission issued a cancellation letter to Northwest Touring

LLC in Docket TE-210509 for failing to submit acceptable proof of insurance, which notified the Company that its authority to provide charter party or excursion carrier service was canceled and that the Company “must immediately cease all operations associated with this certificate.”³ In addition, the letter informed Northwest Touring LLC that “if you advertise or operate without a valid certificate, the commission may take enforcement action against you.”⁴ The cancellation letter was electronically served to Northwest Touring LLC at madsry@gmail.com.⁵

6. On November 1, 2022, I searched Commission records, which showed that Northwest Touring LLC did not have the required authority to provide charter party or excursion carrier service in the state of Washington.⁶
7. On November 1, 2022, I searched Washington Department of Revenue’s (DOR) Business Licensing Service, which produced records showing Northwest Touring LLC in active status in the state of Washington. DOR’s records provided UBI: 604-740-505; listed 520 NE C Street, College Place, Washington, 99324, as both the location and mailing address; and identified Ryan Madsen as the governing person.⁷
8. On November 1, 2022, I searched Washington Secretary of State’s (SOS) Corporations and Charities Filing System, which produced records showing Northwest Touring LLC in active status in the state of Washington. SOS’s records provided UBI: 604-740-505; listed 520 NE C Street, College Place, Washington, 99324, as both the street and mailing address; and identified Ryan Madsen as the governing person.⁸
9. On November 1, 2022, I visited the Company’s Facebook, www.facebook.com/NWTOuring, which provided the phone number (541) 283-6379; listed the email address of info@nwtouring.com; and provided the website address of nwtouring.com/book.⁹ Northwest Touring LLC’s Facebook page contained dozens of posts demonstrating that the Company has continued operating after the cancellation of its charter and excursion carrier service authority.¹⁰ One of those posts, dated September 30, 2022, advertised “a tour for \$79 per person October 1 or October 2” and provided a link to the Company’s website, www.nwtouring.com/book, to make the reservation.¹¹

10. On November 1, 2022, I visited the “Reviews” tab on the Company’s Facebook page, where I found numerous customer reviews referring to transportation services provided by Northwest Touring LLC after the cancellation of the Company’s certificate.¹²
11. On November 1, 2022, I visited the Company’s Instagram page, nwtouring, which shares many of the same photos provided on Northwest Touring LLC’s Facebook page.¹³
12. On November 1, 2022, I visited the Company’s website, www.nwtouring.com, which listed the phone number of (541) 283-6379; listed the email address of info@nwtouring.com; identified Ryan Madsen as the owner; and provided a link to book a tour.¹⁴ On the website’s “Our Tours” page, Northwest Touring LLC provided multiple tour options, to include “mid-week wine tours,” “wine tours,” and “corporate events.”¹⁵ On the website’s “Book Now” page, under an assumed name, I requested wine tour transportation for 15 people on December 10, 2022, and requested that communication be done through text message.¹⁶
13. On November 1, 2022, I received an email from info@nwtouring.com confirming the request I submitted through Northwest Touring LLC’s website. The email provided the phone number of (541) 283-6379 and an address of 520 NE C Street, College Place, Washington, 99324.¹⁷
14. On November 1, 2022, I received a text message from phone number (541) 283-6379 from “Ryan from NW Touring” in response to the submission I made through the Company’s website.¹⁸
15. On November 3, 2022, I responded to the Company’s text message and stated that I was looking for wine tour transportation for 15 people from The Marcus Whitman Hotel in Walla Walla, Washington, to various wineries in the area, and then returned to the hotel. On November 3, Northwest Touring LLC responded to my text message and stated that its “vans are priced at 140 per hour and have a capacity up to 14.”¹⁹
16. On November 8, 2022, I visited the Company’s claimed Yelp page, www.yelp.com/biz/nw-touring-and-concierge-walla-walla, which listed (541) 283-6379 as the phone number;

provided the Company website of www.nwtouring.com/book; and under the “About the Business” section stated, “we specialize in facilitating wine tours, corporate events, wedding transport, and private car service.”²⁰ Under the “Recommended Reviews” section of the Yelp page, I found numerous customer reviews referring to transportation services provided by Northwest Touring LLC after the cancellation of the Company’s certificate.²¹

17. On November 9, 2022, I searched Commission records, which showed that Northwest Touring LLC does not have the required authority to provide charter party or excursion carrier service in the state of Washington.²²
18. Based on paragraphs 3 through 17 above, Commission staff finds that Northwest Touring LLC is operating as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.

On May 25, 2021, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation certificate would be canceled unless you submitted acceptable proof of insurance by June 30, 2021. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, **the Commission has CANCELED your certificate. You must immediately CEASE all operations associated with this certificate. If you advertise or operate without a valid certificate, the commission may take enforcement action against you.**

You have the right to a hearing. If you believe the Commission should not have canceled your certificate, you may ask the Commission to schedule a hearing before an administrative law judge. At the hearing the only issue the Commission will address is whether you had proof of insurance on file to avoid cancellation. Email your request to Mark L. Johnson, Secretary, at records@utc.wa.gov.
