**TO ALL INTERESTED PERSONS:**

On May 20, 2022, PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp) filed with the Washington Utilities and Transportation Commission (Commission) a plan for the electrification of transportation in its service territory. These reports are enabled by RCW 80.28.365, which provides that a utility may submit an electrification of transportation plan that “deploys electric vehicle supply equipment or provides other electric transportation programs, services or incentives to support electrification of transportation.”

PacifiCorp representatives will present the Plan to the Commission for its review and respond to questions from the Commissioners and the public on **Thursday, October 27, 2022, at 9:30 a.m.** The meeting will be held virtually. Interested persons may submit written comments **no later than 5 p.m. on Friday, October 7, 2022.** If you do not file comments but wish to be placed on the interested parties contact list, you may submit your request to the Commission's Records Center at [records@utc.wa.gov](mailto:records@utc.wa.gov).

**WRITTEN COMMENTS**

The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments. Please include:

Comments should be in .pdf format (created using Adobe Acrobat or comparable software) or in Microsoft Word. The Commission will post on its website all comments it receives in electronic format. The website is located at [www.utc.wa.gov](http://www.utc.wa.gov). Documents are generally posted within 24 hours of receipt.

The Commission will consider all comments and determine whether additional scrutiny is warranted. Within six months of submittal of the plan, the Commission will issue a decision determining the plan's compliance with RCW 80.28.365.
