DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age and competent to testify to the facts contained herein.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party or excursion service carriers that may be operating without the required Commission-issued certificate.
3. On October 12, 2017, I searched Washington Department of Revenue's (DOR) Business Licensing Service (BLS), which produced records showing Seattle Town Car Inc., d/b/a Sabra Limo in active status in the state of Washington.¹ DOR's BLS records provided UBI: 603-400-554; listed 2901 S. 128th Street, Tukwila, Washington, 98168, as the location address; listed P.O. Box 1721, Seattle, Washington, 98111, as the mailing address; showed a carrier with an active limousine endorsement for 14 vehicles; and identified Ehab Sabra as the governing person.²
4. On October 16, 2017, I mailed a compliance letter to Seattle Town Car Inc., d/b/a Sabra Limo, which explained that Commission staff (Staff) believed it was operating as a charter party or excursion service carrier in the state of Washington without the required certificate.³ The compliance letter required a written response by October 30, 2017.
5. On November 3, 2017, I emailed info@sabralimoservice.com and provided a recap of a phone conversation from the previous day I had with Ehab Sabra, governing person of

Seattle Town Car Inc., d/b/a Sabra Limo.⁴ In the email, I addressed Port of Seattle's citation for charter operations at the cruise terminal, acknowledged that Seattle Town Car Inc., d/b/a Sabra Limo had an active limousine endorsement through Washington Department of Licensing (DOL), discussed its operations in detail, and provided relevant definitions to Washington Administrative Code (WAC) Chapter 480-30, Passenger Transportation Companies.

6. On November 3, 2017, I received an acknowledgment email from Geno Sabra, Executive Vice President of Sabra Limo Service, Inc., which also provided a mobile phone number of (206) 229-7288; an office phone number of (425) 999-9080; an email address of info@sabralimoservice.com; a website address of www.sabralimoservice.com; and an address of 701 5th Avenue, Suite 97, Seattle, Washington, 98104.⁵
7. On November 14, 2017, the Compliance Investigations Supervisor approved my closing memorandum recommending that Staff open an investigation into Seattle Town Car Inc., d/b/a Sabra Limo should it continue operating as a passenger transportation company requiring Commission authority.⁶
8. On March 14, 2022, I received a complaint that a non-certificated carrier was seen dropping off passengers on March 5, 2022, in a stretch Hummer H2. The complaint included two photos of a white stretch Hummer H2 with license plate CBP1026.⁷
9. On April 13, 2022, I searched DOL's DRIVES application for vehicle information on the white stretch Hummer H2 with license plate CBP1026, which produced records showing the motor vehicle registered to Sabra Transportation Inc., at P.O. Box 1721, Seattle, Washington, 98111, and VIN: 5GRGN23U06H111568.⁸
10. On April 13, I searched Commission records, which provided no record for Sabra Transportation Inc. On the same date, I searched Commission records, which showed that Seattle Town Car Inc., d/b/a Sabra Limo did not have the required authority to provide charter party or excursion carrier service in the state of Washington.⁹
11. On April 13, I searched DOR's BLS, which produced records showing two businesses in the state of Washington registered to Ehab Sabra: Sabra Limo and Sabra Transportation Inc., d/b/a Sabra Limo Service; SeaTac Towncar Inc.

12. DOR's BLS records show that Sabra Limo is registered under UBI: 603-400-554; lists 2901 S. 128th Street, Tukwila, Washington, 98168, as the location address; lists P.O. Box 1721, Seattle, Washington, 98111, as the mailing address; shows one location as closed and the other location as active; and identifies Ehab Sabra as the governing person.¹⁰
13. DOR's BLS records show that Sabra Transportation Inc., d/b/a Sabra Limo Service; SeaTac Towncar Inc., is registered under UBI: 604-411-023; lists 800 SW 16th Street, Renton, Washington, 98057, as the location address; lists P.O. Box 1721, Seattle, Washington, 98111, as the mailing address; shows a carrier with an active limousine endorsement for 11 vehicles; and identifies Ehab Sabra, Ghadir Omran, and Ayman Lukata as the governing people.¹¹
14. On April 13, I contacted DOL to learn which 11 motor vehicles for Sabra Transportation Inc., d/b/a Sabra Limo Service; SeaTac Towncar Inc., are registered as limousine vehicles.¹² DOL responded the same day¹³ and provided a spreadsheet of all 11 registered limousine vehicles.¹⁴ The 2006 white stretch Hummer H2 with license plate CBP1026 and VIN: 5GRGN23U06H111568 is not registered with DOL as a limousine vehicle.
15. On May 25, 2022, I visited the website, www.sabralimoservice.com, which is connected to: (1) Seattle Town Car Inc., d/b/a Sabra Limo; (2) Sabra Limo; and (3) Sabra Transportation Inc., d/b/a Sabra Limo Service; SeaTac Towncar Inc., (collectively, "Sabra Limo").
16. On May 25, under the website's "Reservations" page, I selected "charter" for the service type; entered August 28, 2022, at 10:15 a.m., for the pick-up date and time; selected Tacoma, Washington, as my pick-up and return locations; and selected transportation for 20 passengers on the first step.¹⁵ With those options selected in step one, step two provided me with the options of choosing a 50-passenger motor coach for \$2,109, a 24-passenger mini bus for \$2,166, a 20-passenger Hummer H2 for \$2,508, or a 35-passenger limo for \$3,420.¹⁶

17. On May 25, under the website’s “Contact” page, I submitted a quote request seeking transportation for up to 20 passengers from Tacoma, Washington, to Seattle, Washington, and back on August 28, 2022.¹⁷
18. On May 25, I received an email from Geno Sabra at info@sabralimoservice.com with a quote of \$1,635 for a party bus.¹⁸ Sabra Limo’s email provides a mobile phone number of (206) 229-7288; an office phone number of (425) 999-9080; an email address of info@sabralimoservice.com; a website address of www.sabralimoservice.com; and an address of 701 5th Avenue, Suite 97, Seattle, Washington, 98104; all of which match the contact information from Sabra Limo’s November 2017 email.¹⁹
19. On May 27, 2022, I emailed Sabra Limo and expressed interest in either a bus or stretch vehicle that could transport 18-22 passengers.²⁰ On May 28, Sabra Limo responded to my email and provides an estimate of \$1,650 for either a stretch Hummer H2, two Sprinter vans, or two 10-passenger stretch limos.²¹
20. On July 15, 2022, I searched Commission records, which showed that Sabra Limo does not have the required authority to provide charter party or excursion carrier service in the state of Washington.²²
21. Based on paragraphs 3 through 20 above, Staff finds that Sabra Limo is operating as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.

Dear Mr. Sabra:

The Washington Utilities and Transportation Commission (Commission) believes that you are engaging in passenger transportation services that require a certificate of authority from the Commission. The purpose of this letter is to learn more about the transportation services your company offers and provide technical assistance with respect to Washington's passenger transportation licensing requirements.

One or more of the vehicles registered to your company as defined in WAC 480-30-036, requires a charter certificate from the Commission. Commission records show that you have not obtained the **required** charter certificate to operate charter services. Providing these services without a charter certificate is illegal, considered a gross misdemeanor, and punishable as defined in RCW 81.70.220 and WAC 480-30-246.

To avoid enforcement action by the Commission, no later than October 30, 2017, please do one of the following:

- Submit a completed application, file proof of insurance, and include the application fee to the Commission. For questions about the application process, please contact our Licensing Services staff at (360) 664-1222

OR

- Explain in writing why you believe your business does not require passenger transportation authority from the Commission. Please explain the nature of your operations in detail. Direct your written response to Jason Hoxit, Compliance Investigator, at P.O. Box 47250, Olympia, WA 98504 or by email at JHoxit@utc.wa.gov.

Good morning Mr. Sabra,

I wanted to provide a brief recap of our conversation from yesterday (sorry for the delay):

- The Washington Utilities and Transportation Commission (commission) received a complaint from the Port of Seattle regarding a Seattle Town Car Inc. d/b/a Sabra Limo (Sabra Limo) passenger van at the terminal to charter cruise line passengers on a Vancouver run.
- We discussed that Sabra Limo has a limousine carrier endorsement, as well as limousine vehicles endorsed through the Washington Department of Licensing (DOL).
- We discussed that Sabra Limo provides door to door chauffeured service, which falls under the jurisdiction of DOL.

- We discussed that Sabra Limo provides chauffeured transportation service from private residences to the airport, which would fall under the jurisdiction of DOL.
- We discussed that Sabra Limo seldom provides chauffeured transportation service from the airport to the Pier 91 terminal. It was of my opinion that this service may require auto transportation authority from the commission, but I was not positive. I recommended that this scenario be discussed with the commission's licensing services division, to determine if auto transportation authority would be required.
- We discussed Sabra Limo providing charter services for the cruise line, where the customers are picked up under a single contract to travel together to a specified destination, and then returned back to the cruise ships. I explained that this type of service if provided in a passenger van with a manufacturer's seating capacity of eight or more passengers, including the driver, would require charter and excursion authority from the commission.
- Sabra Limo asked that I look up JPH International, Inc. d/b/a A&A Airport Limousine Service (A&A Limo) to see if/what authority they have with the commission, since your company offers similar service. I explained that A&A Limo has charter and excursion authority from the commission.
- Sabra Limo asked that I look up Shuttle Express, Inc. to see if/what authority they have with the commission, although Shuttle Express's service differs from that of Sabra Limo. I explained that Shuttle Express has both auto transportation authority and charter and excursion authority from the commission.
- I stated that it would be beneficial for you to discuss Sabra Limo's business model with the commission's licensing services division, to determine potential requirements for an auto transportation certificate or a charter and excursion carrier certificate.
- I explained that an application for charter and excursion authority is a competitive industry, however auto transportation authority would be subject to a protest and intervention period.
- I also stated that I would provide some definitions of WACs relevant to auto transportation and charter and excursion carriers. You asked that I send the information to info@sabralimoservice.com (see below):

Auto Transportation Company

WAC 480-30-036:

"Auto transportation company" means every corporation or person, their lessees, trustees, receivers, or trustees appointed by any court whatsoever owning, controlling, operating, or managing any motor-propelled vehicle used in the business of transporting persons and their baggage on the vehicles of auto transportation companies carrying passengers, for

compensation over any public highway in this state between fixed termini or over a regular route, and not operating exclusively within the incorporated limits of any city or town.

"Between fixed termini or over a regular route" means the fixed points between which an auto transportation company provides service or the route over which an auto transportation company ordinarily operates any motor-propelled vehicle, even though there may be variance whether the variance is periodic or irregular.

"Door-to-door service" means an auto transportation company service provided between a location identified by the passenger and a point specifically named by the company in its filed tariff and time schedule.

"Fixed termini" means points of origin and destination that are set, static locations or defined geographic areas. Examples include a city or town, a building or an airport. In addition "fixed termini" can include service between an airport and unlimited points within a defined geographic area.

"Motor vehicle" or "vehicle" means:

(a) As related to auto transportation companies: Every self-propelled vehicle used on the public highways, for the transportation of persons for compensation.

"Route" means a highway or combination of highways over which an auto transportation company provides passenger service. There are two types of routes:

(a) **"Irregular route"** means travel between points named in an auto transportation company's certificate via any highway or combination of highways the company wishes to operate over. The certificate issued to the company does not list highways to be used, but the company defines routes in its tariffs and time schedules.

(b) **"Regular route"** means an auto transportation company providing passenger transportation over a route named in the certificate issued to the company by the commission.

"Scheduled service" means an auto transportation company providing passenger service at specified arrival and/or departure times at points on a route.

Charter and Excursion Carrier

WAC 480-30-036:

"Charter party carrier" or **"charter carrier"** means every person engaged in the transportation over any public highways in this state of a group of persons who, pursuant to a common purpose and under a single contract, acquire the use of a motor vehicle to travel together as a group to a specified destination or for a particular itinerary, either agreed upon in advance or modified by the chartering group after leaving the place of origin. A person who is engaged in the transportation of persons by party bus over any public highway in this state is considered engaging in the business of a charter party carrier or excursion service carrier.

"Excursion service carrier" or **"excursion carrier"** means every person engaged in the transportation of persons for compensation over any public highway in the state from points of origin within any city, town, or area, to any other location within the state of Washington and returning to that origin. The service must not pick up or drop off passengers after leaving and before returning to the area of origin. The excursions may be regularly scheduled. Compensation for the transportation offered or afforded must be computed, charged, or assessed by the excursion service company on an individual fare basis.

"Motor vehicle" or **"vehicle"** means:

(b) As related to charter and excursion carriers: Every self-propelled vehicle with a manufacturer's seating capacity for eight or more passengers, including the driver, used on the public highways, for the transportation of persons for compensation.

Company

Seattle Town Car Inc. d/b/a Sabra Limo

Background

Seattle Town Car Inc. d/b/a Sabra Limo (Sabra Limo or Company) is registered with the Washington Business Licensing Service under UBI: 603-400-554. The Company's location address is 2901 S. 128th St, Tukwila, WA 98168. The Company's mailing address is P.O. Box 1721, Seattle, WA 98111. Ehab Sabra is listed as the governing person. Sabra Limo has an active account with the Department of Revenue and Secretary of State.

Sabra Limo has an active limousine carrier endorsement with the Department of Licensing (DOL) with 14 limousine vehicles registered. Sabra Limo does not have passenger transportation authority from the commission, nor has the Company ever had such authority.

On July 23, 2017, the Port of Seattle contacted staff alleging that Sabra Limo was contracted by Holland America to provide charter carrier service from the cruise ship terminal to Vancouver.

Action

On October 16, 2017, staff sent Sabra Limo a compliance letter outlining charter carrier regulations in the state of Washington. The compliance letter also included language that the Company must cease providing charter services until and unless the commission granted authority. Sabra Limo was asked to explain in writing why the Company believes it does not require passenger transportation authority from the commission, or to apply for operating authority by October 30, 2017.

On November 2, staff spoke with Ehab Sabra, president of Sabra Limo. Staff discussed the complaint regarding the transportation of passengers from the cruise ship terminal in passenger vans with a manufacturer's seating capacity of eight or more; and how that activity requires charter and excursion authority from the commission. Sabra Limo explained that it provides prearranged chauffeured transportation services under its limousine endorsement through DOL, and seldom provides prearranged transportation services from the Pier 91 terminal in passenger vans with a manufacturer's seating capacity of eight or more. Sabra Limo stated that it would submit an application with the commission for charter and excursion authority.

On November 2, Sabra Limo contacted Mike Dotson in the Licensing Services Division to apply for charter and excursion authority. Mr. Dotson advised the Company that it did not need charter and excursion authority from the commission based off the information provided by Sabra Limo. On November 2, Mr. Dotson emailed staff that Sabra Limo did not require charter and excursion carrier authority.

On November 3, staff emailed Mr. Dotson and described the complaint filed by the Port of Seattle. Staff explained to Mr. Dotson that Sabra Limo was operating a 2016 Ford Transit passenger van with a manufacturer's seating capacity of more than eight to transport passengers for Holland America. Mr. Dotson replied to staff on the same day and agreed that the services provided by Sabra Limo as described by the Port of Seattle would require charter and excursion carrier authority.

On November 3, Sabra Limo contacted staff. In the conversation, the Company stated that it is no longer operating any Ford Transit passenger vans, or any other passenger vans with a manufacturer's seating capacity of eight or more. Sabra Limo stated that the van mentioned in the Port of Seattle complaint has since been a total loss, and is no longer in operation. Sabra Limo stated that right now it is only offering limousine and SUV service under its limousine endorsement with DOL. Sabra Limo stated that the tourist season for cruise lines is over and that the Company might be purchasing a Mercedes passenger van for next season. Sabra Limo stated that if the van purchased next year has a manufacturer's seating capacity of eight or more, it will contact the commission to apply for charter and excursion carrier authority.

Recommendation

Staff recommends that the investigation be closed. Sabra Limo has been informed that it must cease from providing passenger transportation services which require charter and excursion carrier authority from the commission. Sabra Limo informed staff that it will not provide passenger transportation services requiring charter and excursion carrier authority until and unless the commission grants the Company operating authority.

If Sabra Limo continues to engage as a passenger transportation company requiring commission authority, staff recommends that a formal investigation be opened.
