## Rate Increase Notice

November 1, 2022

Dear Valued Customer,

Waste Management (WM) is pleased to be your solid waste services collection provider. We value your business and welcome your feedback on our services.

The recyclables we collect from you are processed at WM's Cascade Recycling Center (CRC) in Woodinville, WA. Beginning November 14, 2022, CRC will close for six to nine months, while we install new equipment that uses the latest technology to process recyclables.

During the closure, CRC will be updated with state-of-the-art equipment to improve the quality and quantity of materials sold and enhance safety at the facility. While CRC is closed, WM will transport and process collected recyclables from CRC in Woodinville to our recycling center in Tacoma (JMK Fibers). Because the temporary additional costs due to this closure will be significant, we have applied for a surcharge to our recycling collection rates, subject to the review and approval of the Washington Utilities and Transportation Commission (WUTC). If approved, the surcharge would become effective December 1, 2022, and remain in effect for 90 days. The surcharge would be reviewed for renewal each succeeding 90 days and adjusted up or down based on any changes to our expenses incurred. The initial surcharge requested is \$2.32 per month.

The WUTC has the authority to set final rates that may vary from the company's request, depending on the outcome of its investigation. - Sort plastics by the shape (bottles, tubs, and jugs) - ignore numbers and symbols
- Keep recyclables loose in your cart – do not bag recyclables
- Ensure all recyclables are clean, dry, and empty
