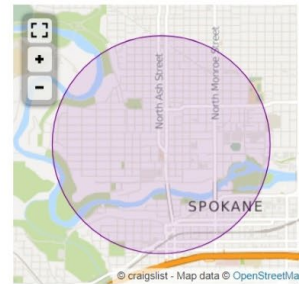

The Utilities and Transportation Commission has information that you are conducting household goods moves within the state of Washington. Advertisements for your household goods moving services have been found at craigslist.org. You do not have a valid permit, as required by state law, to conduct this type of work. Conducting household goods moves requires a permit issued by the commission.

To avoid enforcement action, your complete household goods permit application, supporting materials, and application fee must be submitted to the commission by **Oct. 5, 2015**.

Until you obtain a permit, you must immediately cease operating as a household goods mover in Washington state. Operating as a household goods mover without the required permit is illegal and subject to a penalty of **\$5,000 per violation**. This means that you may receive this penalty for each day you operate in violation of the law.

You must also immediately cease advertising as a household goods mover in Washington state. Advertising for the transportation of property for compensation in Washington without a proper permit is against the law. The penalty for advertising without a permit is **\$5,000 per violation**. This means that you may receive a penalty for each and every advertisement. At this time, the commission has documented advertisements for household goods moving services from Budget Movers and Triple A Movers.

If you advertise or operate as a household goods mover without a permit, the commission will take enforcement action against you. Such action will include the above-mentioned financial penalties; and you will be served with a subpoena and be required to appear before a judge.

Again, to avoid enforcement action, your complete application, supporting materials and application fee must be submitted to the commission by **Oct. 5, 2015**.

The Washington Utilities and Transportation Commission (commission) has information that you are conducting household goods moves within the state of Washington. Advertisements for your household goods services have been found on www.thumbtack.com. Conducting or advertising household goods moves requires a permit issued by the commission. You do not have a valid permit, as required by state law, to conduct this type of work.

Until you obtain a permit, you must immediately cease operating as a household goods mover in Washington State. Operating as a household goods mover without the required permit is illegal and subject to a penalty of **\$5,000 per violation**.¹ This means that you may receive this penalty for each day you operate in violation of the law.

You must also immediately cease advertising as a household goods mover in Washington State. Advertising for the transportation of property for compensation in Washington without a proper permit is against the law. The penalty for advertising without a permit is **\$5,000 per violation**. This means that you may receive a penalty for each and every advertisement. At this time, the commission has documented advertisements for household goods moving services from Sara Andrea Ybarra, d/b/a Quality Movers, d/b/a Precision Movers, d/b/a Ultimate Movers.

If you advertise or operate as a household goods mover without a permit, the commission will take enforcement action against you. Such action may include the above-mentioned financial penalties; and you will be served with a subpoena and be required to appear before a judge.

Dear Shane Pablo and Sara Ybarra:

The Utilities and Transportation Commission (commission) sent you a letter dated March 9, 2020, regarding your company, Quality Movers. Commission staff found advertisements for household goods services within the state of Washington. You were informed:

- state law requires a valid permit, issued by the commission, to advertise and operate as a household goods mover in Washington State;
- you may receive a penalty of \$5,000 per violation for each and every advertisement to transport property for compensation;
- you may receive a \$5,000 penalty for each day you operate without the required permit;
- until you obtain a permit from the commission, you must immediately cease operating and advertising as a household goods mover in Washington State; and
- in order to avoid enforcement action, your complete household goods permit application, supporting materials, and application fee must be submitted to the commission.

As of June 15, 2021, your company's page on www.yelp.com, www.thumbtack.com, www.craigslist.com, and www.facebook.com, still list Spokane and surrounding areas as cities your company services. It appears that your company continues to advertise and operate without the required permits.

Operating or advertising as a household goods mover, solid waste hauler, or common carrier without the proper permits from the commission is illegal and subject to a \$5,000 penalty per violation. Until you obtain the proper commission issued permits, you must immediately cease and desist from operating or advertising as a household goods mover, solid waste hauler, or common carrier in Washington State.

To avoid enforcement action, you must stop operating and advertising as a household goods mover immediately. In addition, **by June 30, 2021**, you must do one of the following:

- a) Submit completed household goods moving permit application, proof of insurance, supporting materials, and application fee. To request a permit application, please call (360) 664-1222. You may also download an application from the commission's website at www.utc.wa.gov/regulated-industries/transportation/regulated-transportation-industries/household-goods-carriers.

OR

- b) Explain in writing why you believe your operations do not require authority from the commission. Please explain your operations in detail. Direct your written response to Ryan Grimes, Compliance Investigator, at ryan.grimes@utc.wa.gov or to P.O. Box 47250, Olympia, WA 98504.


