Dear Ms. Maxwell:

In connection with Docket UE-230277, Puget Sound Energy (“PSE”) hereby submits the work papers supporting the proposed tariff update of Schedule 85 costs and margins that PSE filed with the Washington Utilities and Transportation Commission (“Commission”) on May 22, 2023.

There are no revisions to any of the proposed tariff changes or the tariff sheets issue date or the effective date.

Per the discussions between PSE and the Commission energy staff, PSE is submitting two of the work papers in the redacted version only. The Commission energy staff had reviewed all three work papers without redaction of confidential information and did not have any changes to these work papers. The two redacted work papers are marked per WAC 480-07-160.

After the initial tariff filing, PSE worked with the Commission consumer protection staff in the drafting of the notice to builders. On May 25, 2023, PSE emailed the notice to the building associations in the region for their distribution to their members to make builders aware of this filing and the proposed line extension charges, costs, and margin amounts.

The tariff sheets described herein reflect an issue date of April 20, 2023, and an effective date of July 1, 2023. Posting of the proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed in accordance with WAC 480-100-193(1). No additional public notice is required under the provisions of WAC 480-100-194 or -195. Furthermore, PSE provides a cost quote to individual customers who request facility extension or modification prior to construction.
