Recycling (commodity) credit/debits included in Tariff No. 4 pages 21, 21A, 25, 25a, 25b, and 30.

*** Present provisions are:**
Residential single family recycling credit is \$0.00. Multi-family credit is \$0.00. Multi-family 3.5x compacted credit is \$1.97.

*** Proposed changes are:**
Residential single family recycling debit is \$0.30. Multi-family debit is \$0.10. Multi-family 3.5x compacted debit is \$0.35.

*** Explain why the company is proposing this tariff revision:**
This is an annual calculation of the recycling commodity credit.

*** Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**
As previously allowed per WAC 480-70-271, customer notices were to be included no later than the first billing to affected customers due to the passthrough nature of the annual commodity credit adjustment. Rabanco Ltd. would like to continue providing similar notice to customers.
