NOTICE OF PETITION FOR DECLARATORY ORDER

Re: Kalama Water LLC
Petition for an Order authorizing access to Company property under WAC 480-110-305,
Docket UW-240615

TO ALL INTERESTED PERSONS:

On August 12, 2024, Kalama Water LLC (Kalama or Company) filed a Petition (Petition) for a Declaratory Order pursuant to RCW 34.05.240 and WAC 480-07-930. The Petition requests that the Commission issue an Order authorizing the Company to access Company property located at 224 Resort Lane, Kalama, WA 98625. Kalama is a Class B water system regulated by the Washington Utilities and Transportation Commission (Commission) under Tariff UW-151792 and pursuant to RCW Title 80 and WAC Title 480.

Pursuant to RCW 34.05.240 and WAC 480-07-930, the Commission gives notice of this Petition to all persons required by law and such other persons as deemed appropriate. Within 30 days of receiving the Petition, the Commission must either enter a declaratory order; notify the petitioner that no order will be entered; set a time by which the Commission will enter an order; or set a time for a hearing.

THE COMMISSION GIVES NOTICE that any interested persons may respond to the Petition by filing a written response with the Commission no later than 20 days from the date of this notice.
