Annual Power Cost Adjustment Mechanism filing, requesting approval for revisions to Tariff Schedule 97 and Schedule 99 resulting in a net power cost revenue requirement increase of \$59.5 million, or 10 percent, to be recovered over 12 months effective October 1, 2025.
