YOU MUST RESPOND WITHIN 15 DAYS OF THIS NOTICE

The Washington Utilities and Transportation Commission (Commission) believes that Clearwater Summit Group, Inc. (Clearwater Summit or Company) violated Revised Code of Washington (RCW) 19.122.055(1)(a) by failing to notify the one-number locate service and causing damage to an underground gas facility.

RCW 19.122.055(1)(a) states, in part, that excavators who fail to notify a one-number locator service and cause damage to an underground gas facility are subject to a civil penalty of not more than \$10,000 for each violation.

Commission staff (Staff) conducted an investigation that included reviewing damage reports, investigation reports, the One Call Center database, and communications with the Company. The reviewed documents identified a natural gas event that involved Clearwater Summit damaging a natural gas facility while excavating without a valid locate ticket.

The Commission hereby notifies you that it is assessing a \$1,000 penalty (Penalty Assessment) against you on the following grounds:

1. Alleged Violation:

On May 21, 2025, Clearwater Summit was excavating at 619 S. Easy St, Airway Heights, Washington. While excavating, Clearwater Summit workers struck and damaged an underground Avista Corporation (Avista) natural gas facility. The Damage Information Reporting Tool (DIRT) report submitted by Avista on June 9, 2025, indicated that Clearwater Summit was excavating without a valid request to locate underground utilities.

2. Analysis:

The alleged violation concerns RCW 19.122.055(1)(a), which states, in part, that an excavator must contact the one-number locate center before beginning excavation. On May

21, 2025, Clearwater Summit Group damaged an Avista gas line. The First Responder Report from Avista indicates that Clearwater Summit Group dug into an Avista 2" gas main line with a backhoe.

On July 17, 2025, staff emailed Clearwater Summit and requested further information regarding this damage incident. On July 17, 2025, Clearwater Summit responded and stated it had submitted its DIRT report as required. On July 18, 2025, Staff communicated with Clearwater Summit that this investigation involved an alleged violation of the Dig Law and that further information was still needed from the Company. On July 28, 2025, Staff again sent follow-up email to Clearwater Summit requesting information. As of this date no further responses have been received from Clearwater Summit Group.

The Commission considered the following factors in determining the appropriate penalty amount for the violation:

1. How serious or harmful the violation is to the public.

This incident could have been significantly more harmful to Clearwater Summit workers, utility technicians, nearby homeowners, and the public, and it could have resulted in severe injury and/or loss of property.

2. Whether the violation is intentional.

The violation appears to be due to negligence rather than a lack of knowledge of Washington State's Dig Law. Over the past 12 months, Clearwater Summit has submitted 61 requests to the One Call Center for locates. This demonstrates the Company's knowledge of requirements and its responsibility to contact the one-number locate service before beginning excavation.

3. The likelihood of recurrence.

The likelihood of recurrence depends on the Company's actions going forward and its willingness to notify the one-call location service every time prior to excavation.

4. The Company's previous violations and penalties.

On July 22, 2014, and November 21, 2018, the Commission mailed Alleged Violation of Washington Dig Law letters to Clearwater Summit. The letters included detailed information about Washington State's Underground Utility Damage Prevention Act, requirements for submitting utility locate requests before excavating, and the possibility of penalties for each violation. The Commission mailed the letters after receiving reports of damage caused by Clearwater Summit that occurred because the Company failed to submit requests to locate underground utilities before excavating.

The Commission has considered these factors and agrees with the Safety Committee's findings of probable violation and penalty recommendation, as follows:

• \$1,000 penalty for one violation of RCW 19.122.055(1)(a) with an offer to suspend an \$800 portion of the penalty for one year, and then waive it, subject to the conditions that:

- 1) Company management and field crew responsible for excavation complete Dig Safe Training provided through the National Utility Contractors Association (NUCA) within 90 days of this Penalty Assessment;
- 2) The Company must submit documentation of training completion to the Commission; and
- 3) The Company must not commit any further violations of RCW 19.122 within 12 months of the date of this Penalty Assessment.

These facts, if proven at a hearing and not rebutted or explained, are sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Or, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for a hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. See RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

<u>You must act within 15 days after receiving this Penalty Assessment</u> to do one of the following:

- Pay the \$1,000 penalty amount due; or
- Pay \$200 and notify the Commission that you accept the offer to suspend an \$800 portion of the penalty amount subject to the following conditions:
 - Company management and field crew responsible for excavation at the time of the incident, must complete NUCA Dig Safe training (https://utc-9183.quickbase.com/db/bpkt6vndh) within 90 days of service of this Penalty Assessment; and
 - o The Company must submit documentation of training completion (Certificate) to the Commission. (See attached **NUCA Dig Safe Training Verification Record**); and
 - The Company must not incur any additional violations of RCW 19.122 within 12 months of the date of this Penalty Assessment; or
- Request a hearing to contest the occurrence of the violation; or
- Request mitigation to reduce the amount of the penalty.
