In addition to the foregoing, statutes involved are those within chapters 80.04 and 80.28 RCW, including but not limited to RCW 80.04.220, 80.04.230, 80.04.240, 80.04.380, and 80.04.450, as well as those within chapter 80.28 RCW relating to the charges and practices of water companies. Rules involved include WAC 480-110-081 and those within chapter 480-110 WAC relating to water service, and chapter 480-09 WAC. The issues involved are generally stated above and more specifically contained in the pleadings herein.
