RE: Increases to Container and Packing Rates in Commission Published Household Goods Tariff 15-C Docket TV-210035

TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) will publish revisions to Tariff 15-C (Household Goods) with a proposed effective date of July 30, 2021. The Commission will consider the tariff changes proposed by Commission staff (Staff) at its regularly scheduled open meeting on July 29, 2021.

The proposed tariff changes would increase the maximum container rates listed in Item 196 – Container Prices and Item 225 – Container Prices by 12 percent. The container portion of the maximum rates listed in Item 195 – Packing Charges would also increase by 12 percent. These tariff revisions are being proposed pursuant to a container price increase notification provided by the Washington Movers Conference from Pioneer Packaging, which provided notice of a 12 percent price increase on all containers, effective May 24, 2021.

Proposed revisions to Tariff 15-C are reflected in Attachment 1: Cover Page; Page 39 containing Item 195 – Packing Charges; Page 40 containing Item 196 – Container Prices; and Page 49 containing Item 225 – Container Prices. Revisions are noted in track changes.
