On November 1, 2023, Avista Corporation d/b/a Avista Utilities (Avista) and Puget Sound Energy (PSE) filed their gas Biennial Conservation Plans (BCPs)¹ for the period 2024-2025. On November 15, 2023, Cascade Natural Gas Corporation (Cascade) and Northwest Natural Gas Company d/b/a NW Natural (NW Natural) filed their gas BCPs for the period 2024-2025.
