In accordance with WAC 480-07-640, Company A requests approval of the fully negotiated amendment to an interconnection agreement, as described below:

Amendment Number: 7

Description of amendment: This amendment entitled "*Triennial Review Order and Triennial Review Remand Order ("TRO/TRRO") Amendment Number 6 to the Interconnection Agreement between Qwest Corporation and TCG Seattle for the State of Washington*" deletes certain UNEs and/or changes or adds terms and conditions for certain UNEs as set forth in Attachment 1 and Exhibit A, attached to this amendment.

This amendment amends the interconnection agreement first approved by the Commission on February 6, 2004 in WUTC Docket No. UT-033035 (original docket number), and any amendments approved to date in WUTC Docket No. UT-043125.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
