**A. Rules**

- i) Child Fares are available to all children age 11 and under, traveling with a paying passenger.
- ii) Adult Fares apply to persons age 12-64.
- iii) There will be no charge for infants under 1 year who do not occupy a seat.
- iv) Adult and Child Advance Purchase Fares are only valid and available for reservations booked and paid for a minimum of 1 day prior to travel. Capacity is controlled. Changes are not allowed after the scheduled departure time of the reservation. Customers who fail to show up by the scheduled departure time of their reservation at the designated pick-up point or who have not cancelled or changed their reservation at least 24 hours prior to that time are not eligible for a refund. Refunds will be made if the carrier's delay or cancellation caused the cancellation or change. Refunds may be granted by the Company due to other extenuating circumstances. (N)
- v) Child Advance Purchase/Free Fare is only valid and available for a child traveling with a full fare paying adult. Limit 1 Child/1 Adult. Reservations must be booked and paid for a minimum of 1 day prior to travel. Capacity is controlled. Changes are not allowed after the scheduled departure time of the reservation. Customers who fail to show up by the scheduled departure time of their reservation at the designated pick-up point or who have not cancelled or changed their reservation at least 24 hours prior to that time are not eligible for a refund. Refunds will be made if the carrier's delay or cancellation caused the cancellation or change. Refunds may be granted by the Company due to other extenuating circumstances. (N)
- vi) Child Fares are also available to all Travel Arrangers (persons in the business of arranging travel for others) on a space-available basis. No reservations are allowed under this fare.
- vii) Schedule Maintenance: Carrier will not be liable for delays caused by accidents, breakdowns, weather or other conditions beyond its control. Though every effort will be made to meet the published time schedule, the carrier makes no guarantee to arrive or depart from any point at any time.
- viii) Objectionable Passengers: The company reserves the right to refuse to transport persons under the influence of drugs or alcohol, or who are incapable of taking care of themselves, or whose condition, conduct or behavior may be objectionable to other passengers. The company reserves the right to refuse carriage of any materials considered unsafe or not in the best interest of the passengers.
- ix) Baggage Rules and Charges: No charge for up to two bags per passenger. Baggage beyond two bags per person or baggage or packages placed on the vessel for transport (with no accompanying passenger) will be charged \$10.00 per bag. Baggage or package weight limit of 70 pounds per bag. No bicycles allowed.
- x) Animals: No Dogs, cats and other small animals or birds. Seeing-eye dogs can travel with their owners in the cabin area.
