First Supplemental Response:

In addition to the audits Puget Sound Energy, Inc. ("PSE") conducts of Pilchuck compliance, which PSE is making available for review (as provided in PSE's Response to WUTC Staff Data Request No. 003), PSE satisfies its obligation for self-audits under WAC 480-93-188(6) by conducting ongoing review and edits of data entered at the time it is entered.

Further, PSE regularly reviews information on each gas leak ticket for completeness. This review is conducted via a programming feature within PSE's leak management database. Specifically, a programming feature in PSE's leak management database causes any incomplete leak repair records to be flagged for review. PSE's Maintenance Program Coordinator then reviews the flagged record and consults with those individuals responsible for the data to ensure that accurate and complete data is entered into the leak management system.
