2 Petitioners' claims are stated in the written Petition for Review, a copy of which is served upon you
3 with this Summons.


4 In order to defend against this lawsuit, you must respond to the Petition for Review by
5 stating your defense in writing, and by serving a copy upon the person signing this Summons within
6 twenty (20) days after service of this Summons, if service is made within the State of Washington,
7 or within sixty (60) days of service if service is made without the State of Washington, excluding
8 the day of service, or a default judgment may be entered against you without notice. A default
9 judgment is one where the Petitioners are entitled to what they are asking for because you have not
10 responded. If you serve a Notice of Appearance on the undersigned person, you are entitled to
11 notice before a default judgment may be entered.

13 You may demand that the Petitioners file this lawsuit with the Court. If you do so, the
14 demand must be in writing and must be served upon the person signing this Summons. Within
15 fourteen (14) days after you serve the demand, the Petitioners must file this lawsuit with the Court,
16 or the service on you of this Summons and Petition for Review will be void.

18 If you wish to seek the advice of an attorney in this matter, you should do so promptly so
19 that your written response, if any, may be served on time.
