Pursuant to Order 08 Approving and Adopting Settlement Stipulation; Authorizing Transaction Subject to Conditions (the “Final Order”) issued by the Commission on December 30, 2008, in WUTC Docket No. U-072375, Puget Holdings LLC (“Puget Holdings”) and Puget Sound Energy, Inc. (“PSE”) file the following documents to replace similar documents electronically filed on the evening of February 3, 2009:

- (i) a replacement Attachment A (Schedule 132–Merger Rate Credit to the WN U-60, Tariff G for electric service of PSE, which provides for rate credits for electric service in compliance with Commitment No. 34 in the Multiparty Settlement Stipulation, Exhibit A to the Final Order);
- (ii) a replacement Attachment B (Schedule 132–Merger Rate Credit to the WN U-2 tariff for natural gas service of PSE, which provides for rate credits for natural gas service in compliance with Commitment No. 34 in the Multiparty Settlement Stipulation, Exhibit A to the Final Order);
- (iii) a replacement Attachment C (Affidavit of Christopher J. Leslie on behalf of Puget Holdings in compliance with the second condition of the Final Order);

- (iv) a replacement Attachment D (Affidavit of Christopher J. Leslie on behalf of Puget Holdings in compliance with the third condition of the Final Order); and
- (v) a replacement Attachment H (Affidavit of Christopher J. Leslie on behalf of Puget Holdings in compliance with the eleventh condition of the Final Order).

The enclosed replacement Attachment A (proposed Schedule 132 for electric service) and replacement Attachment B (proposed Schedule 132 for natural gas service) state an effective date of Friday, February 13, 2009, for each such Schedule 132. An effective date of February 13, 2009, balances (i) the time necessary for the transaction to close and PSE to update its billing system and (ii) the expeditious implementation of the rate credit to benefit PSE's customers.

The affidavits of Christopher J. Leslie filed on the evening of February 3, 2009, were not dated. The enclosed replacement Attachment C (Affidavit of Christopher J. Leslie on behalf of Puget Holdings in compliance with the second condition of the Final Order), replacement Attachment D (Affidavit of Christopher J. Leslie on behalf of Puget Holdings in compliance with the third condition of the Final Order), and replacement Attachment H (Affidavit of Christopher J. Leslie on behalf of Puget Holdings in compliance with the eleventh condition of the Final Order) have dates inserted into each such affidavit.

Puget Holdings and PSE respectfully request receipt of a letter accepting the filing on the evening of February 3, 2009, as supplemented and revised by this filing, no later than the close of business on Thursday, February 5, 2009, to allow the transaction to close as planned on Friday, February 6, 2009.
