**NOTICE RESCHEDULING VIRTUAL PREHEARING CONFERENCE**  
**(Now set for December 18, 2020, at 9:30 a.m.)**

RE: *Murrey's Disposal Co., Inc. v. Waste Mgmt. of Wash., Inc., Waste Mgmt. Disposal Services of Or., and MJ Trucking & Contracting and Murrey's Disposal Co., Inc. v. Waste Mgmt. of Wash., Inc., Waste Mgmt. Disposal Services of Or., and Daniel Anderson Trucking and Excavation, LLC*  
Dockets TG-200650 and TG-200651 (*Consolidated*)

TO ALL PARTIES:

On July 15, 2020, Murrey's Disposal Company, Inc. (Murrey's Disposal or Company), filed with the Washington Utilities and Transportation Commission (Commission) separate complaints against Waste Management of Washington, Inc. (WMW), Waste Management Disposal Services of Oregon, Inc. (WMDSO), and MJ Trucking & Contracting, Inc. (MJ Trucking) and WMW, WMDSO, and Daniel Anderson Trucking and Excavation, LLC (DAT) (collectively, Respondents), asking the Commission to order WMW, WMDSO, MJ Trucking, and DAT to cease and desist from engaging in the collection and transportation of solid waste without a certificate of authority from the Commission and to find that certain intermodal motor carrier transportation services offered by WMW or WMDSO are not preempted by 49 C.F.R. § 1090.2.

On August 4, 2020, Respondents filed with the Commission Answers to the complaints and motions to dismiss pursuant to WAC 480-07-380(1).

On October 19, 2020, the Commission entered Order 02, denying the Respondents' motions to dismiss.

On October 21, 2020, the Commission issued a Notice of Virtual Prehearing Conference in these consolidated dockets, setting a virtual prehearing conference for November 5, 2020, at 1:30 p.m.

On October 29, 2020, Respondents filed a Petition for Interlocutory Review and Reversal of Order Denying Motion to Dismiss (Petition).

The Commission finds good cause to reschedule the virtual prehearing conference to December 18, 2020, at 9:30 a.m. to afford the Commission an opportunity to determine how to resolve Respondents' Petition.
