In accordance with WAC 480-07-640, Company A requests approval of the fully negotiated amendment to an interconnection agreement, as described below:


Amendment Number: 10

This Agreement is hereby amended to incorporate the rate set forth in the revised Exhibit A, attached to the Agreement, for which the Parties will charge each other for, "End Office Call Termination, "Tandem Switched Transport and "Tandem Transmission." In addition, the specific rates applicable for local Transit Traffic and intraLATA Transit Traffic have been included in the revised Exhibit A attached to this Amendment.

This amendment amends the interconnection agreement approved by the Commission on February 11, 1998 in Docket No. UT-960354.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
