19 This matter, having come before the Court pursuant to RCW 34.05.570 on the Petition
 20 for Judicial Review of Petitioner Inland Telephone Company ("Inland"), and the Court having
 21 considered the briefing of the parties, and having also considered the administrative record and
 22 the oral argument of counsel on September 21, 2007, and being fully advised, the Court now
 23 rules as follows:

- 24 (1) Inland has not shown under RCW 34.05.570(1)(d) that it has been
 25 substantially prejudiced by the actions complained of.

- 1 (2) Under RCW 34.05.570(3)(d) the Commission correctly interpreted
2 and applied the law.
- 3 (3) Under RCW 34.05.570(3)(e) the Commission's order is supported
4 by evidence that is substantial when viewed in light of the whole
5 record before the court.
- 6 (4) Under RCW 34.05.570(3)(f) the Commission decided all issues
7 requiring resolution.

8 The Court therefore ORDERS that Inland's Petition for Judicial Review is DENIED.
