SCHEDULE 211 SPECIAL RATE ADJUSTMENT SCHEDULE 90-T AND SCHEDULE 91-T

APPLICABLE:

To any "electing Customer." An electing Customer is any non-residential Customer receiving service on or before December 31, 1998 on any rate schedule (the original schedule) under the *Tariff* of which this schedule is a part, that subsequently elects service under **SCHEDULE 90-T**, "Basic Firm Transportation Service", or **SCHEDULE 91-T**, "Basic Interruptible Transportation Service", on or after June 1, 1999. This schedule does not apply to new Customers joining the Company's distribution system after December 31, 1998.

PURPOSE:

This Schedule applies a rate adjustment to Customers that migrate to Transportation Service rate schedules, **Schedule 90-T**, "Basic Firm Transportation Service", and **Schedule 91-T**, "Basic Interruptible Transportation Service", on or after June 1, 1999.

RATE ADJUSTMENTS:

The margin surcharge is based on permanent rates in effect with service on and after December 1, 1998, and actual historic monthly usage of the electing Customer during 1998.

Period 1. June 1, 1999 through May 31, 2000

Margin Migration:

The electing Customer shall pay a monthly margin surcharge equal to the difference in margin on a specified number of therms priced at:

- A. The permanent rate for the electing Customer's original schedule less the commodity charge and the average firm demand charge and
- B. The electing Customer's current schedule either SCHEDULE 90-T or SCHEDULE 91-T.

In addition to the monthly margin surcharge, the electing Customer shall also pay:

A. The temporary adjustment(s) applicable to the original schedule as set forth in Schedule 208, "Temporary Rate Adjustment (FAS 106)", effective with service on and after December 1, 1998.

The therms used to calculate the above amounts shall equal the lesser of (i) the Customer's actual **Schedule 90-T** or **Schedule 91-T** usage, or (ii) the Customer's actual historic usage in the same billing month of 1998.
