AWEC does not request paper service, unless required by WUTC rules or law.

AWEC is an incorporated, non-profit association of large energy consumers in the Pacific Northwest. AWEC represents some of Puget Sound Energy's ("PSE" or the "Company") largest customers.

AWEC has a substantial interest in PSE's filing, which the Company originally filed on November 15, 2024, and the purpose of which is to "request cost recovery for an increase to the state-required Climate Commitment Act [] allowance costs through the State Carbon Reduction Charge [] and to also to provide an increase to the pass back of auction proceeds through the State Carbon Reduction Credit." At an Open Meeting held in front of the Commission on December 19, 2024, the Commission allowed rates to go into effect on an interim basis while concluding that further investigation into PSE's Schedule 111 is necessary and set the matter to adjudication.²

The Company's proposed tariff revision could substantially and directly affect AWEC members who purchase natural gas services from PSE. Accordingly, AWEC requests leave to intervene in this proceeding to represent its members who would be affected by any change to PSE's rates.

AWEC has extensive experience in proceedings before the Commission involving PSE. AWEC participated in the Company's last general rate case ("GRC"), Dockets UE-240004/UG-240005, and has participated in several prior rate filings for Schedule 111 specifically. AWEC has also been a party in many prior Company rate proceedings over the past decades, either under its own name or through its predecessor organizations the Industrial

Customers of Northwest Utilities and the Northwest Industrial Gas Users. AWEC's intervention

in this proceeding will assist the Commission in resolving issues and will not unreasonably

that will not be adequately represented by any other party and may be affected by any

Commission determination made in connection with this proceeding. Thus, it is in the public
