1. The Public Counsel Unit of the Washington State Attorney General's Office (Public Counsel) hereby offers this Public Comment Exhibit Bench Request No. 1 (BR-1) for admission into the record of the proceeding. On December 20, 2022, the Washington Utilities and Transportation Commission (Commission) issued a Notice of Virtual Public Comment Hearing (Notice) scheduled for 6 p.m. on January 24, 2023. The Commission and Public Counsel both received and compiled remarks from customers in response to Puget Sound Energy's Clean Energy Implementation Plan (CEIP) Docket UE-210795. Customers provided comments to the Commission either by email or through its online web portal. Public Counsel received comments via email.

Public Comment Exhibit No. BR-1. The Commission Consumer Protection and Communications Staff documented comments in a database matrix. - 3. The UTC Comment Matrix and its comment attachments and the comments received by Public Counsel include all comments submitted from the time the 2021 Draft CEIP was filed on October 15, 2021, through the final date of the hearing for this Docket on January 24, 2023. Commission Staff provided the comment matrix to Public Counsel on February 23, 2023.
