Dear Mr. King:

As a result of the formal collaborative process conducted in the above-captioned dockets, Public Counsel, Commission Staff, and Puget Sound Energy (PSE) (Joint Parties) have reached an agreement on proposed changes to PSE's Power Cost Adjustment. Industrial Customers of Northwest Utilities (ICNU) participated in the collaborative, but has advised the Joint Parties that it opposes the settlement.

The Joint Parties plan to file a settlement agreement and supporting testimony by January 30, 2015. The Commission can then set the matter for hearing, or otherwise determine how to proceed. PSE and Commission Staff have authorized Public Counsel to file this letter on behalf of the Joint Parties. ICNU was notified of the letter.
