SERVICE CONNECTION CHARGE

Applicable

To lot owners in the Hunt I & II Water System when water service is requested to the lot initially.

1. A charge of \$3,500.00 will be made the first time a lot is connected to the utility's main.

2. At the time service is physically connected, a connection charge of \$1,115.00 will be assessed and paid by the customer for connections of 3/4". Connections larger than 3/4" will be made on a time and materials basis. These non-refundable charges do not include the cost of a meter, which will be furnished, installed and maintained by the utility.

3. The utility will own and maintain all materials involved in making a service connection.

4. The service connection charge will be paid before the water is turned on.
