1 **NATURE OF PROCEEDINGS.** In 2005, Pac-West Telecomm, Inc. (Pac-West) and Level 3 Telecommunications, LLC’s (Level 3) (collectively Competitive Local Exchange Carriers or CLECs) filed with the Washington Utilities and Transportation Commission (Commission) petitions for enforcement of their interconnection agreements with Qwest Corporation, which has now become Qwest Corporation d/b/a CenturyLink QC (Qwest). After the Commission’s 2006 final orders were challenged in federal court and remanded for decision, the Commission consolidated the proceedings and resolved the legal issues on remand. The Commission will conduct an evidentiary hearing to address the remaining factual issues.

2 **AGREED REQUEST TO POSTPONE EVIDENTIARY HEARING.** On Tuesday, November 20, 2012, Level 3 notified the Commission that one of its lead attorneys would be unavailable for the evidentiary hearing scheduled for December 5 and 6, 2012, because he had sustained a serious injury and will be unable to travel to

Olympia, Washington, in December. Level 3 indicated that all parties had agreed to postpone the hearing until February 2013.

3 On Monday, November 26, 2012, all parties confirmed their agreement to reschedule the evidentiary hearing in this matter to February 6-7, 2013.

4 The Commission finds that Level 3 has presented good cause to reschedule the evidentiary hearing. The Commission will grant the parties' agreed request to postpone the hearing until February 6-7, 2013.

5 **NOTICE OF HEARING.** The Commission will convene an evidentiary hearing in this matter **on February 6 and 7, 2013. The hearing will commence at 9:30 a.m. on Wednesday, February 6, 2013, in Room 206 of the Richard Hemstad Building, 1300 S. Evergreen Park Drive S. W., Olympia, Washington.** As necessary, the hearing will continue and conclude on Thursday, February 7, 2013.
