- 6 Transportation Commission on Monday, November 10th,
- 7 2008, for a prehearing conference in consolidated
- 8 dockets of TO-031973, in re the matter of the petition
- 9 of Olympic Pipe Line Company, Tesoro Refining and
- 10 Marketing Company, and Conoco Phillips Company, for an
- 11 order approving the terms of Amendment No. 7 to the
- 12 2003 tariff settlement agreement and approving rates
- 13 set to pursuant agreement, as well as the consolidation
- of Docket TO-081785, in re the matter of the petition
- 15 of Olympic Pipe Line Company for an order approving

- 18 The purpose of this prehearing conference is
- 19 to take appearances of the parties, discuss the
- 20 schedule for the Commission's consideration of the
- 21 settlement agreements and the underlying initial
- 22 filings to answer any requests for intervention and to
- 23 take up any other procedural matters that the parties
- 24 may raise.
- Why don't we go ahead and take appearances.

- 25 any kind of exhibits or what have you, I don't

- 1 anticipate, but should they wish to file any, we
- 2 require four copies along with the original, and they
- 3 need to be filed electronically as well.
- 4 We also discussed the possibility of the
- 5 parties, or I should say the ALJ, getting out an order
- 6 by December 5th, possibly earlier, but that is my
- 7 target date, December 5th for an initial order, and
- 8 then possibly having something in place for a final
- 9 order a week or so after that depending on what happens
- 10 with the parties' filing letters. If they wish to
- 11 waive the review, and with that... Did you have
- 12 something else, Mr. Trotter?
- MR. TROTTER: Yes, Your Honor. Thank you.
- 14 In the narrative, Page 3, we identified pleadings on
- 15 file with the Commission that support the agreement or
- 16 give it context. Is it necessary to make separate
- 17 exhibits out of those, or can the Commission just refer
- 18 to those as part of the record in making its
- 19 determination?
- 20 JUDGE RENDAHL: The Commission can either
- 21 take notice or we can prepare a draft exhibit list that
- 22 would include the settlement documents and any
- 23 supporting documents and circulate that to the parties.
- MR. TROTTER: My only concern is whether we
- 25 need to make additional copies of that material.
