I Paul Henrickson, under penalty of perjury under the laws of the State of Washington, declares as follows:

I object to all hearsay and including emails, pictures and any other pertinent information pertaining to this docket. The information that has been provided has not been created by me or Concrete and More.

- 1. I or Concrete and More never did business with as transportation company of garbage. Kathryn McPherson is delirious and creates non-sense. I was never sent any timely mail and her research is from other businesses that strive to earn twenty percent on anything they sell. I am not in the garbage business. Nonetheless I did my due diligence in tracking down advertisers that state the word garbage. According to RCW 34.05.110 Kathryn McPherson continued her relentless pursuit, because of anger and mislead administration not only with not following rules, but claiming I was properly served for court hearing where she acquired a Judgement. Her mind shows ill will since we spoke about court the prior business day and was notified that I was not aware of any change for court date. So, her information on past addresses and emails never were properly sent and she received a verdict in her favor.
- 2. Concrete and More never advertised as a solid waste carrier. I do not see any proof of any approvals of advertising. Kathryn McPherson creates havoc. I have received harassing phone calls where I've had to threaten police intervention. As I told her I do not advertise garbage.
- 3. The address provided by Kathryn McPherson is very old and not involved with me. According to Kathryn McPhersons mailing and RCW states someone may correct any advertisements that were aimed at me. I did my due diligence with any other contacts that were attempting to gain off of me and believed they were advertising for their best interests. I made them aware of any circumstances and therefore have not heard anymore complaints from Kathryn McPherson and is not that the goal of her position. Instead we have an ongoing argument two years later.
- 4. There is no record of as a solid waste carrier since I am not involved.

- 5. The address that Kathryn McPherson sent a letter to was never received and again not involved. This was an old home address where not one letter was ever in my awareness was written to Concrete and More.
- 6. Kathryn McPherson claims the "from the Company" as a return to sender. I had no involvement in what the mail carrier does. Nor, have I seen any letters.
- 7. Kathryn McPherson did contact me and I was not aware of the situation. This led to an argument and I believed it to be a scam. I do receive a lot of phone calls in regards to companies who try and represent me and offer 20% commissions. I have never done business with any of them. They try and sell leads and I told Kathryn she was uneducated and had the wrong person and that I do not do business with any of them.
- 8. I never told Kathryn McPherson "smallest truck of the dump" and I did say there would be no personal information over the phone exchanged. She was very rude and accusing of things that did not matter to me since I was not involved.
- 9. This was my current address
- 10. I responded by phone call to Kathryn and she explained that ads cannot state garbage. I informed her that I do not operate as garbage and have no care for it. I told her that I would inform anyone that contacts me that they were causing problems.
- 11. Concrete and More was what it stated as in construction.
- 12. I have no idea what she is referring to found more information. There is no advertising for Concrete and More anywhere on the net that I am aware of.
- 13. I do not see the advertisement and or the date that she can say was created before or after any awareness to garbage advertisements.
- 14. I did not respond or receive any emails from Kathryn McPherson in regards to picking up garbage. Also, I would like to point out that in the photo contains junk such as barbecue. The phone number she also provides in the letter does not match my number.
- 15. In reference to her photo and her analysis of picking up garbage is that it would be illogical that someone would pay \$100 for garbage bags when their argument is, they charge too much. If I were to respond to an email this would be a go away email and statement to go through the garbage company.

This matter coming before the Utilities Transportation Commission has been ultimately timely and confusing. I've never operated as garbage collection company. This was caused from an argument had between Kathryn McPherson and I which became more volatile, which led to harassing phone calls, crank calls, harassment, threats of police, name calling and more.

I was contacted by phone by Kathryn McPherson and I explained I had no idea what she was referring to as garbage collection company. Informed her that the information was incorrect. In turn this led into a major argument on the phone and has led us to where we are at today. Except that this is from an argument from harassment and name calling. There has been no garbage collections and Kathryn McPherson use the Utilities and Transportation as to justify her own in competencies and as a means for her own fights. Since then I have been constantly harassed, the system misleads and being used as a tool where there has been a lot of wasted resources. It is my understanding that there have been hundreds of emails, letters, phone calls which have included many individuals. Unfortunately, this is waste of tax payers dollars that goes unwarranted for Kathryn McPhersons lack of education.

In conclusion you have not heard of anymore ad about garbage or anything about me since. The goal of the committee is to warn and release as long as garbage is emitted and the person does not do business in garbage. I have never done business in garbage so this is not relevant to me.
