Referring to Mr. Duvall's statement that PacifiCorp "plan[ned] to not sell any Washington allocated eligible RECs during the twelve-months ending March 31, 2012," please answer the following:

- (a) Is Mr. Duvall aware of any executed sales contracts for Washington-allocated eligible RECs covering any portion of the twelve months ending March 31, 2012?
- (b) If Mr. Duvall *is* aware of any executed sales contracts for Washington-allocated eligible RECs covering any portion of the twelve months ending March 31, 2012, please explain how any such executed sales contracts fit into "the Company's plan to not sell Washington RECs" during the twelve months ending March 31, 2012.
- (c) If Mr. Duvall *is* aware of any executed sales contracts for Washington-allocated eligible RECs covering any portion of the twelve months ending March 31, 2012, please explain the basis of Mr. Duvall's statement (on page 3 of his Rebuttal Testimony) that rates should reflect REC revenue only "[i]f the Commission orders the Company to sell Washington-allocated RECs in the rate effective period," i.e., why Mr. Duvall seems to suggest that the Company is awaiting a Commission order to sell RECs before actually committing to such sales.
- (d) If Mr. Duvall *is not* aware of any executed sales contracts for Washington-allocated eligible RECs covering the twelve months ending March 31, 2012, please **[Begin Confidential]** XXXXXXXX
