Pursuant to the procedural schedule adopted by Administrative law Judge Karen

M. Caille, the Northwest Industrial Gas Users ("NWIGU") hereby submit this Initial

Brief in the above-referenced proceeding.

NWIGU is a signatory to the Settlement Agreement, along with Staff, Avista

Corporation, and the Energy Project (collectively the "Signing Parties"). NWIGU

supports the Settlement Agreement. At hearing the Industrial Customers of Northwest

Utilities ("ICNU") and Public Counsel have challenged the settlement. ICNU has only

challenged the settlement of the electric case, raising no objections to the settlement

impacting natural gas customers of Avista. Public Counsel has raised some issues

regarding the settlement of the natural gas portion of the case, but the focus of its

criticism is also directed at the electric settlement.

NWIGU urges the Commission to approve the settlement of the natural gas case.

NWIGU witness Schoenbeck, as well as Staff witnesses and company witnesses have

shown through overwhelming evidence that the settlement of the gas case reaches a fair

result for Avista's gas customers and its shareholders. No party has raised a serious issue

with the gas settlement that should cause this Commission to reject it. NWIGU urges the

Commission to approve the gas settlement as filed.
