- 1 On September 27, 2002, the Commission entered the Twentieth Supplemental Order in Docket No. TO-011472 Order Rejecting Proposed Tariffs; Authorizing and Requiring Refiling; Ordering Refunds of Excess Interim Rate Collections.
- 2 On October 8, 2002, Olympic Pipe Line Company (Olympic) filed two tariff filings, WUTC No. 24 and Supplement No. 1 to WUTC No. 24, in compliance with the Commission’s Twentieth Supplemental Order. On October 10, 2002, Olympic filed revised tariff pages to correct minor typographical errors and to attach an additional spreadsheet to Supplement No. 1. The proposed tariffs, filed to be effective October 15, are attached as Appendix A to this Order, which is incorporated into and made a part of this Order.
- 3 On October 11, 2002, Commission Staff filed a letter indicating Staff has reviewed the tariff filings and state that Olympic’s October 10, 2002, tariff filing appears to comply in all respects with the Commission’s Twentieth Supplemental Order. The Commission finds that the tariffs filed by Olympic on October 8, 2002, as revised in the tariff pages filed on October 10, 2002, comply with the Commission’s Twentieth Supplemental Order in Docket No. TO-011472 and that the tariffs filed on October 10, 2002, should be approved and become effective on October 15, 2002.

4 By the terms of the Twentieth Supplemental Order, other parties were afforded the opportunity to respond to Commission Staff's submission within two business days. No party filed a response opposing the filing.

ORDER

5 THE COMMISSION ORDERS That the revised compliance tariff filings filed by Olympic Pipe Line Company on October 10, 2002, are in accordance with the Twentieth Supplemental Order in this proceeding and shall become effective on October 15, 2002.

6 THE COMMISSION FURTHER ORDERS That jurisdiction is retained by the Commission to effectuate the provisions of this and prior Orders entered in this proceeding.
