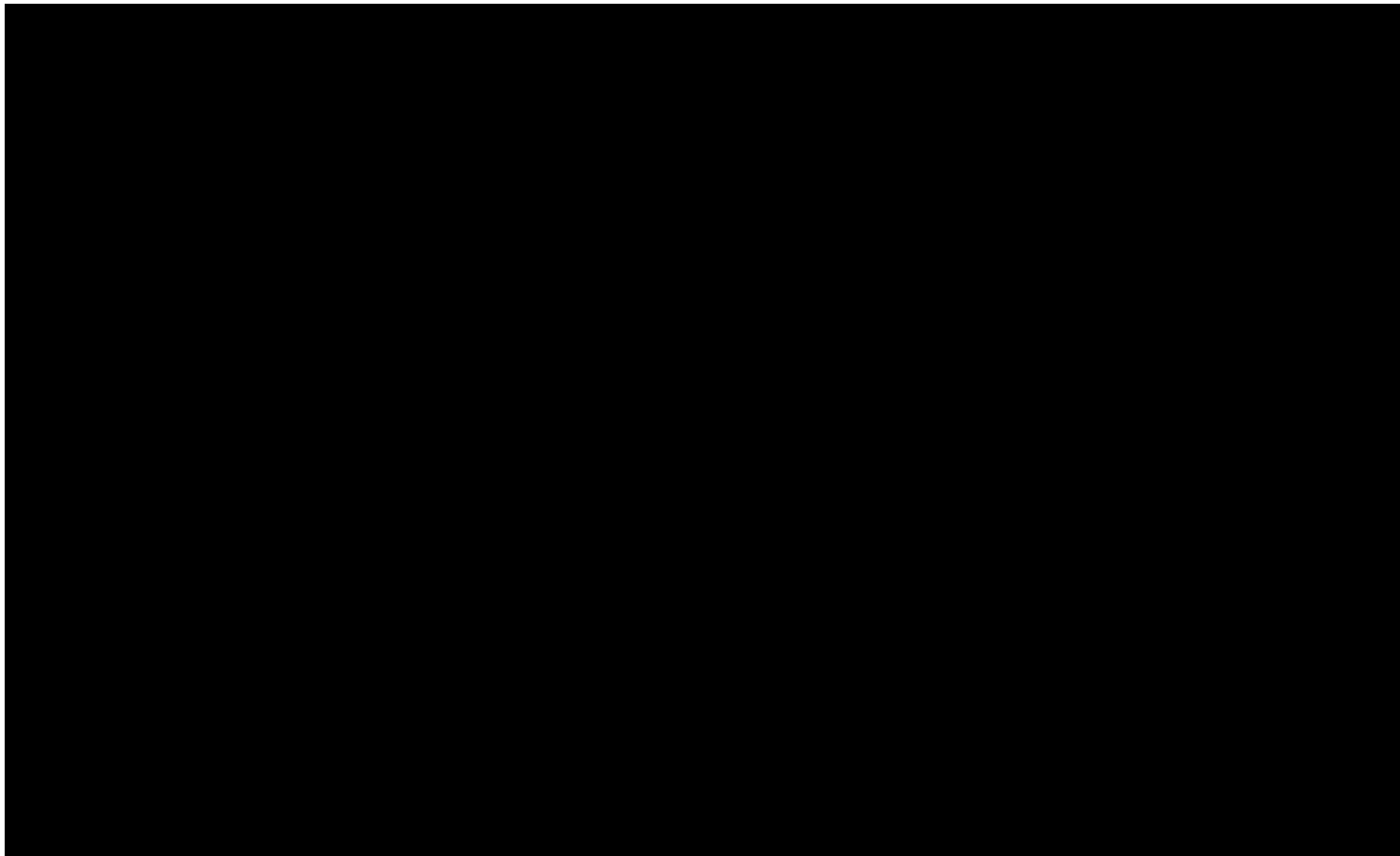

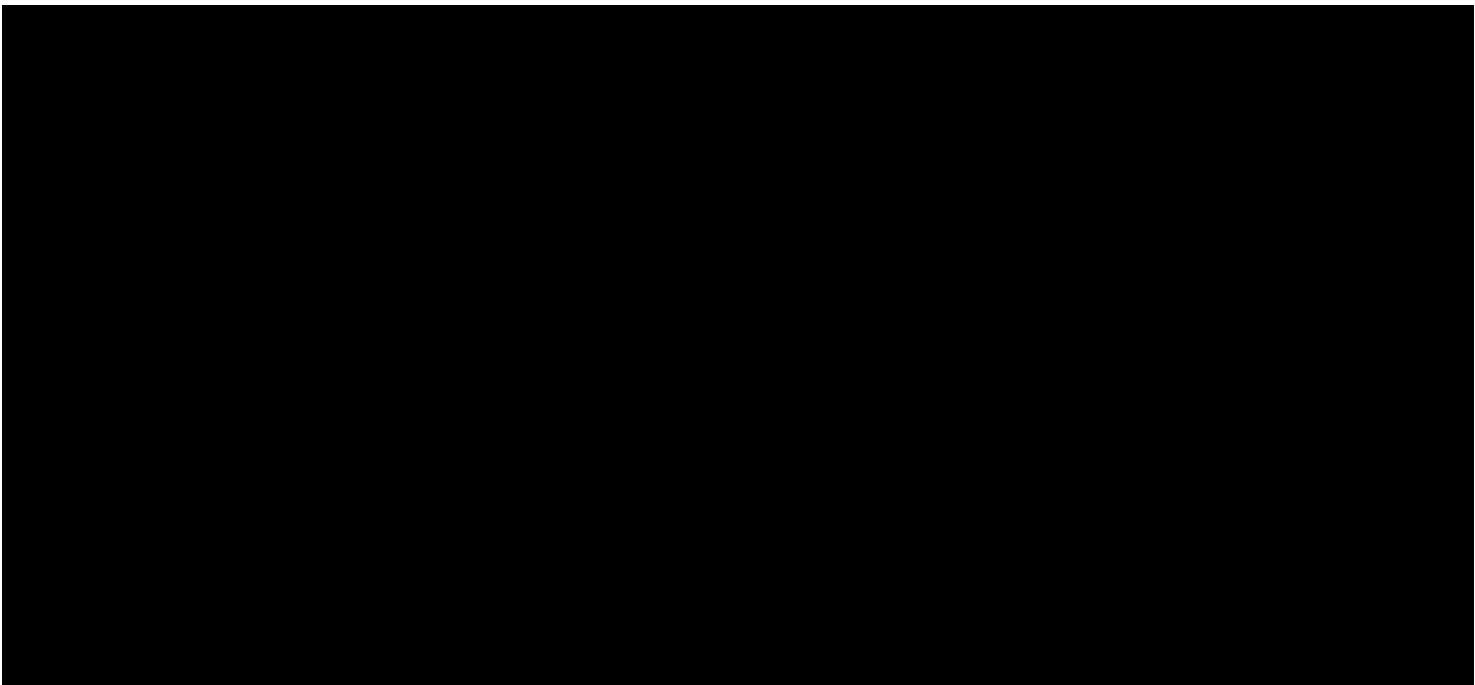

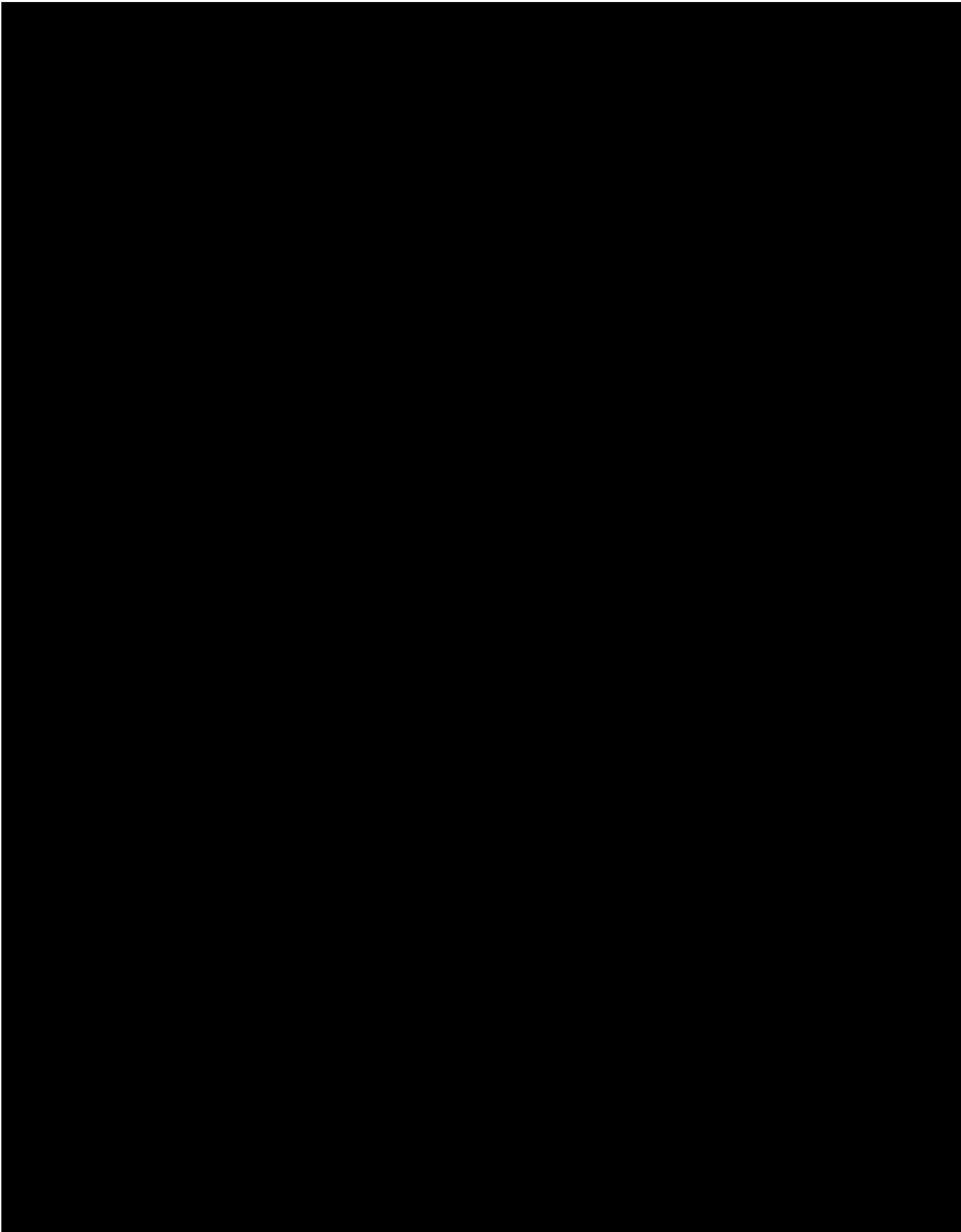
- a) Provide the number of insurance claims filed by the Company under each insurance policy with the related amount for each claim for each year from 2016 to 2021.

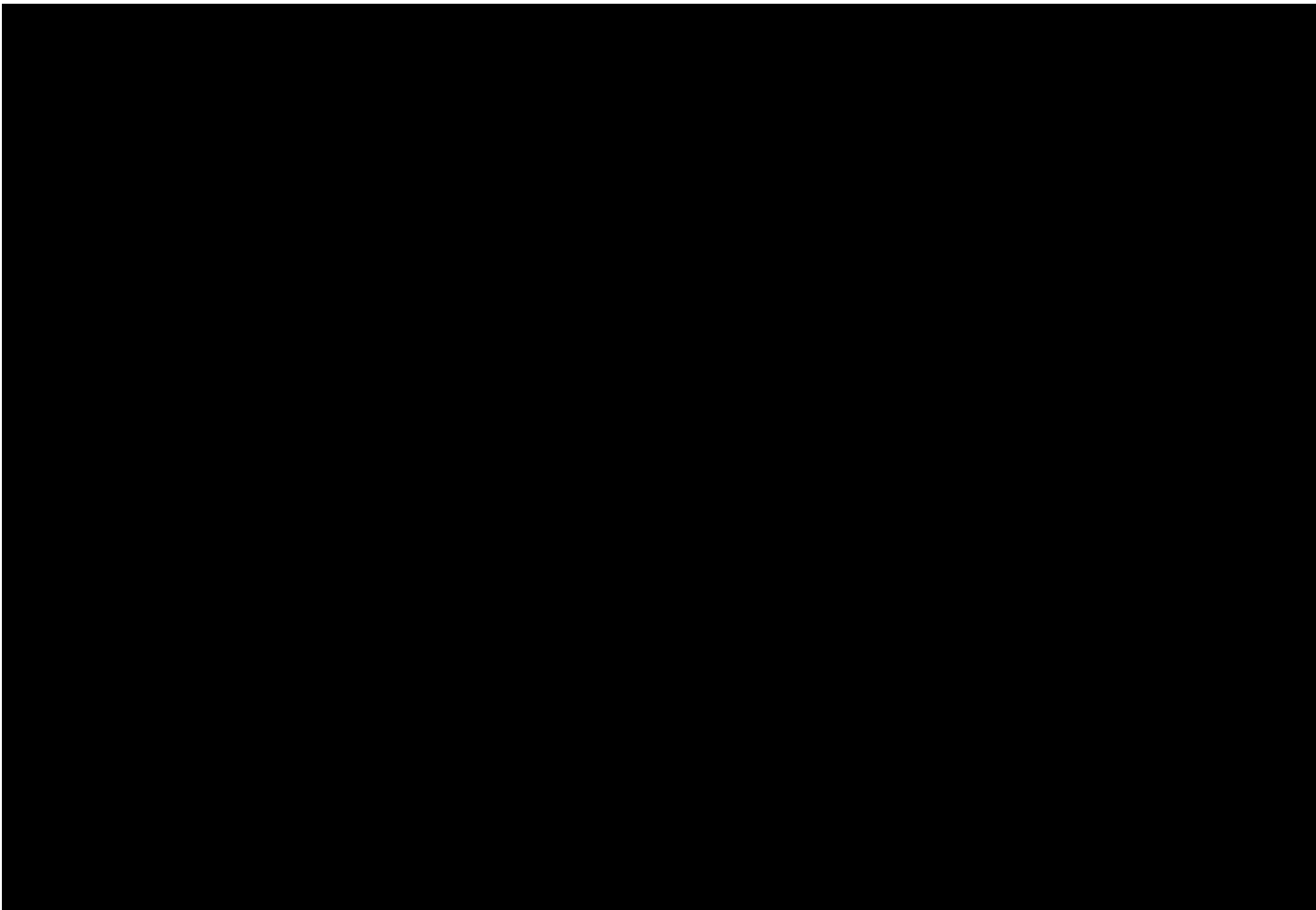
