Subject: Docket UE-200980

Members of the Utilities and Transportation Commission,

I am writing on behalf of Sound Transit to provide comment on the joint settlement for Docket UE – 200980 as it relates to Puget Sound Energy's Green Direct program. Sound Transit has subscribed to both phases of Green Direct and has enrolled all existing properties served by PSE into the program under two 10-year contracts. As a result, we currently operate the only light rail system in the country running on 100% clean energy.

We are reaching out to the commission to share our concerns with the proposed change in methodology for the Energy Charge Credit calculation, which is the portion of the joint settlement that is relevant to Green Direct.

Although Sound Transit anticipated and planned for appropriate adjustments in the Energy Charge Credit amount based on market conditions, it was not anticipated that the methodology previously agreed upon to determine the Energy Charge Credit amount for Green Direct would change. As a result of the proposed changes, Sound Transit is anticipating significant increases to projected utility costs for sites served by Puget Sound Energy.

The change in the calculation methodology for the Energy Charge Credit in the Green Direct program will negatively impact the program's financial performance for our agency. Instead of the modest financial benefits we had projected, we now anticipate significant additional costs for electricity. As a result, our agency will incur new energy costs that were neither anticipated nor budgeted, and this is especially challenging in the context of pandemic-related agency efforts to reduce costs to deliver our capital expansion program.
