**Subject: Information for Basin Frozen Foods, Inc. – Regulated Pipeline Company of the Washington Utilities and Transportation Commission**

Pipeline Safety Staff of the Washington Utilities and Transportation Commission (WUTC) has attached documents that will help bring you up-to-date on the compliance actions that have taken place on Basin Frozen Foods, Inc. Furthermore, Staff has provided links to the rules and laws governing pipeline companies operating in the State of Washington.

1. 3<sup>rd</sup> Supplemental Order Accepting Settlement and the Amended Settlement Agreement between the WUTC and Basin Frozen Foods, Inc. which was issued on May 14, 2003 (attached).
2. Current penalty assessment form that shows the balance owing of \$13,333.35 (attached).
3. Current Washington Administrative Code (WAC) 480-93 (Natural Gas Safety). Please visit the WUTC Pipeline Safety website to view the natural gas rules: [www.wutc.wa.gov/pipeline](http://www.wutc.wa.gov/pipeline) Click on the link Laws & Rules.
4. Please note that WAC 480-93 is currently being reviewed within a WUTC rulemaking, docket number UG-011073. We have attached a copy of the proposed draft rules and will add your name to the interested parties list for this rulemaking. Formal adoption of the new natural gas safety rules WAC 480-93 is likely to occur in February 2005. 6. As a reminder, the WUTC 2004 Standard Inspection of Basin Frozen Foods, Inc. will occur during the week of November 15 – 19, 2004. Scott Rukke, Pipeline Safety Engineer, will conduct the inspection.
