On October 24, 2023, in Docket UE-230877, Pacific Power submitted a filing with the Washington Utilities and Transportation Commission (UTC) to propose tariff amendments that would: (I) limit damages arising out of the Company's provision of electric services to actual economic damages; (2) exclude a-typical damages (including special, non-economic, punitive, incidental, indirect, or consequential); (3) only apply prospectively, and for actions arising out of the provision of electric service; and (4) not apply where state law otherwise disallows the limitation.
