TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in the Washington Utilities and Transportation Commission's (Commission) rulemaking in Docket UT-073014 to consider amending WAC 480-120-071, Extension of service, relating to requirements for extension of service to customers within a company's service territory, and WAC 480-120-103, Application of service, relating to requirements the applicant and the company must meet for a service application. This letter also provides notice of an opportunity to file written comments on proposed rules and participate in the formal rule adoption hearing.

On May 7, 2008, the Commission filed a notice of proposed rulemaking (CR-102) in this docket with the Code Reviser. The proposal would allow an applicant an extension of up to 1000 feet at no charge and would require the applicant to bear the cost of extending plant beyond 1000 feet. In addition, the terminating access charge method of cost recovery would be eliminated for future extensions. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
