Proposed general rate increase that would generate \$88,000 (22 percent) additional annual revenue. The existing capital surcharge for treatment plant will remain in place until November 2023. Additionally, ancillary charges will also be adjusted to recover cost directly incurred by customers. The company serves 624 customers in near Friday Harbor, in San Juan County. The proposed effective date is May 1, 2021. The company's last general rate increase was effective on March 1, 2012, for \$35,594 (8.2 percent).
