Appendix A focused on regulated electric and gas companies. Recognizing a need for similar guidance for regulated water companies, staff developed the UTC Staff Water Utility Options COVID-19 Recovery, referred to as Appendix B. Staff Investigation

- The commission will include in the order language that preserves the commission's ability to assess penalties if the company fails to file by January 1, 2022, going back to the original deadline of October 1, 2021
