General rate increase request that, as originally filed, would have generated approximately \$116,000 (7.6 percent) additional annual revenue for the collection of garbage services. Staff and the Company have agreed to a lower additional annual revenue amount of approximately \$70,000 (4.5 percent) resulting in lower revised rates. The Company provides regulated solid waste collection service to approximately 1,230 residential customers in Pend Oreille County. The Company's last general rate increase became effective on February 1, 2016.

Staff and the Company have agreed to a revised revenue requirement of \$954,717 (7 percent) resulting in revised rates. The revised rates for garbage, recycling, yard waste services are lower than the original rates noticed to customers. The Company provides regulated solid waste collection service to approximately 26,200 customers in Yakima County. The Company's last general rate increase became effective on May 1, 2021.
