Jing Roth, Interim Director, Regulatory Services, indicated that items F26 and F27, Docket No's UE-220888 and UG-220889 were removed from the agenda and that an addendum for item E15, Docket No. TS-220908, Arrow Launch Service, Inc., was created to correct a clerical error.

- A)1. 11:32 mp4 Docket Number UG-220801; Puget Sound Energy; Revises Tariff WN U-2, Schedule 137 Carbon Offset Service. Because the market for voluntary carbon offsets has become more competitive, the Company proposes to increase the monthly rate per block from \$3.00 to \$4.50 for every 400 pounds of Carbon Dioxide Equivalent. The company also proposed to add additional clarifying language to the tariff regarding the therm equivalent per Carbon Offset for greater transparency. Tariff Revision

- B)1. 20:23 mp4 Docket Number TG-220823; Harold LeMay Enterprises, Inc. ; General rate increase for Pierce County Refuse to correct calculation errors in rates allowed in Docket TG-220548 which became effective October 1, 2022. The rates filed in the docket were calculated incorrectly and will not provide the agreed to revenue requirement for the Company. This filing is to correct those rates and increase revenue requirement by approximately \$18,000 to account for a notice to customers with explanation of the error and appropriate rates.
