The regular meeting of the Washington Utilities and Transportation Commission was called to order on Wednesday, November 22, 2023 by Chairman Danner. It also includes proposed Tariff Revision to WN U-60 Schedule 95, Power Cost Adjustment Clause, and Schedule 139, Voluntary Long Term Renewable Energy Purchase Rider to collect deferral balance from the Power Cost Adjustment Mechanism. The Company is requesting a revenue increase of \$27.4 million or .96 percent, effective December 1, 2023. A typical residential customer using 800 kWh would see a \$1.07 increase on their bill each month. Petition

- Deferring the prudency determination for the Chelan Power Supply Agreement (PSA) until PSE's next General Rate Case filing.
- Approving PSE's proposed method to recover the 2022 PCA customer deferral balance via revisions to Tariff WN U-60 Schedule 95, Power Cost Adjustment Clause, and Schedule 139, Voluntary Long Term Renewable Energy Purchase Rider.

Including the following condition:

• Future PCA Mechanism report filing petition and cover letter must include the following language "Per Attachment A to the Settlement Stipulation approved under Final Order 11 in Docket UE-130617 the "Commission must review and approve the filing by September 30 of that year." Until a new order modifies the review timeframe, the updated review deadline shall be included in the filing petition and cover letter.
