3. UG-231044 **Avista Corporation**

Revises Tariff WN U-29 to establish temporary Schedule 162 - Climate Commitment Act (CCA), for the purpose of passing on to customers the Company's CCA compliance costs and revenues for calendar year 2023. A typical residential customer using 64 therms per month would see an increase of \$3.06 per month, or 3.3 percent. Known low-income customers would receive a credit that fully offsets the CCA charge rate, resulting in a \$0.00 charge to those customers.

6. TG-240114 **Sound Disposal Holdings**

Tariff revisions for a commodity adjustment \$1.19 decrease (debit decrease from \$2.81 to \$1.62) per month for residential recycling customers, a \$0.28 decrease for 96-gallon receptacle per pick up (debit decreasing from \$0.65 to \$0.37), a \$1.63 decrease for 1.25 yd receptacle per pickup (debit decrease from \$2.80 to \$1.17), \$1.93 decrease for 1.5 yd (new container size) receptacle per pickup, and \$2.50 decrease for 2 yd (new container size) receptacle per pickup per month for multi-family recycling customers.
