The regular meeting of the Washington Utilities and Transportation Commission was called to order on Thursday, April 25, 2024 by Chairman Danner. A)1. 4:17 mp4 Docket Number UE-240191; Puget Sound Energy; Petition for approval of the independent evaluator for the Company's requests for proposals to acquire energy resources, in accordance with WAC 480-107-023(2). Petition

Disposition: Commissioner Rendahl moved to issue an Order in Docket UE-240191 granting Puget Sound Energy's petition approving Bates & White to serve as the independent evaluator for any voluntary requests for proposals (RFP) issued by the Company before January 1, 2027, on condition that:

• Prior to issuing each targeted voluntary RFPs in the allotted period, PSE must consult with interested parties, including Commission staff (Staff) and Public Counsel, to determine if there are concerns with the use of Bates & White. As part of this consultation, PSE will describe Bates & White's qualifications in the given area of the potential RFP. If interested persons identify concerns that the Company does not resolve, they may petition the Commission in this Docket for approval of an independent evaluator.

Commissioner Doumit seconded the motion. The motion carried (3:0)

A)2. 8:56 mp4 Docket Number UG-240141; Cascade Natural Gas Corporation; Revises Tariff WN U-3 to establish Schedule 700 - Temporary Climate Commitment Act (CCA) Rate Adjustment, for the purpose of passing through to ratepayers the Company's CCA compliance costs and revenues accrued through December 31, 2024. Net recoverable CCA compliance costs are \$31.25 million. An average non-low-income residential ratepayer using 55 therms per month would see an increase of \$2.83 per month, or 3.69 percent. Known lowincome ratepayers would receive a credit that fully offsets the CCA charge rate resulting in a \$0.00 charge to those ratepayers. Tariff Revision

The Company serves 133 domestic customers on one water system near Sequim located in Clallam County. The Company's last general rate case became effective April 1, 2019. Tariff Revision

The Company serves 634 customers in Friday Harbor, in San Juan County. The Company's last general rate case became effective May 1, 2021. Tariff Revision

B)1. 1:33:30 mp4 Docket Number TG-240111; Waste Connections of Oregon, Inc.; General rate increase request that, as originally filed, would have generated approximately \$263,614 (83 percent) additional annual revenue for the collection of garbage services. Staff and the Company have agreed to a lower additional annual revenue amount of approximately \$248,701 (78 percent) resulting in lower revised rates. The Company provides regulated solid waste collection service to approximately 235 residential, commercial, and roll off garbage customers in Benton County. The Company's last general rate increase became effective on August 1, 2008. Tariff Revision

B)2. 1:44:19 mp4 Docket Number TG-240147; Rabanco Ltd.; General rate increase request for Rabanco Ltd. d/b/a Eastside Disposal that generates approximately \$534,269 (7.08 percent) additional annual revenue for the collection of garbage, recycling, yard waste services. The Company provides regulated solid waste collection service to approximately 29,000 residential and commercial garbage, recycling, and yard waste customers in King County. The Company's last general rate increase became effective on May 1, 2023. Tariff Revision

Disposition: The commissioners took no action, thereby allowing tariff pages filed by Rabanco LTD, d/b/a Eastside Disposal, d/b/a Republic Services, on February 28, 2024, to become effective May 1, 2024, by operation of law.

B)3. 1:50:32 mp4 Docket Number TG-240177; Island Disposal, Inc.; A compliance filing from Island Disposal Inc., set forth in Order 02 of Docket TG-220100, which is a general rate increase request that generates approximately \$0 (0 percent) total additional annual revenue. This request increases roll-off rates by approximately 6.95 percent while reducing residential rates by 1.01 percent and reducing commercial rates by 0.37 percent for the collection of garbage services. The Company provides regulated solid waste collection service to approximately 12,700 residential, 975 commercial, and 130 roll-off customers in Island County.

The Company's last general rate increase became effective on April 1, 2022. Tariff Revision

B)4. 1:54:27 mp4 Docket Number TG-240180; Harold LeMay Enterprises, Inc.; General rate increase request that, as originally filed, would have generated approximately \$1,056,500 (9.4 percent) additional annual revenue for the collection of garbage, recycling, and yard waste services. Staff and the Company have agreed to a lower additional annual revenue amount of approximately \$838,000 (7.4 percent) resulting in lower revised rates. The Company provides regulated solid waste collection service to approximately 17,500 residential, 15,850 recycling, 300 multi-family recycling, 500 yard waste, 2,700 commercial, and 120 roll-off customers in Lewis and Thurston counties. The Company's last general rate increase became effective on September 1, 2020. Tariff Revision
