Less than statutory notice request by Waste Management of Spokane to add new services requested by customers for bear resistant containers. These tariff revisions also correct a clerical error in a previous filing that removed the Environmental Programs charge. That fee is set by Spokane County Environmental Services, at the North County Transfer Station and the Valley Transfer Station. On January 1, 2024, the charge increased from \$2.00 per vehicle to \$3.00 per vehicle. The Company serves approximately 26,000 garbage customers in Spokane County.
