General rate increase request that, as originally filed, would have generated approximately \$1.8 million (4.98 percent) additional annual revenue for the collection of garbage, recycling, yard waste services. Staff and the Company have agreed to a lower additional annual revenue amount of approximately \$1.4 million (4.05 percent) resulting in lower revised rates. The Company provides regulated solid waste collection service to approximately 70,000 (residential/recycling/yard waste) customers in Thurston County. The Company's last general rate increase became effective on March 1, 2022.

The Company provides regulated solid waste collection service to approximately 15,470 residential, 1,200 commercial, 125 roll-off, and 16,000 residential recycling customers in Mason County. The Company's last general rate increase became effective on April 1, 2021.

General rate increase request that generates approximately \$2,437,000 (7.9 percent) additional annual revenue for the collection of solid waste. Staff and the Company have agreed to a lower additional annual revenue amount of approximately \$2.2 million (7.1 percent) resulting in lower revised rates. The Company provides regulated solid waste collection service to approximately 78,000 residential, 400 commercial, 400 roll-off customers in Clark County. The Company's last general rate increase became effective on July 1, 2022.

Less than statutory notice request for tariff revisions by Waste Management of Skagit County that would generate approximately \$36,000 (0.6 percent) additional annual revenue to recover the increased cost of disposal fees set by the Skagit County Board of Commissioners. On September 1, 2024, disposal fees will increase from \$105.00 per ton to \$137.00 per ton at the Skagit County Recycling and Transfer Station. The Company serves approximately 11,250 residential and 1,270 commercial customers in Skagit County. The Company's last general rate increase became effective December 1, 2018.

The proposed changes would result in an annual rate decrease for customers of approximately \$4.1 million, or 1.0 percent of base revenue. A residential customer with typical usage of 1,200 kWh per month would see a monthly bill decrease of \$1.38 per month, or 1.1 percent. Tariff revisions that would generate approximately \$24,600 (0.88 percent) additional annual revenue to recover the increased cost of disposal fees set by the Wasco Landfill. On September 1, 2024, disposal fees will increase from \$31.20 per ton to \$32.07 per ton at the Wasco Landfill.
