## 6. TG-250009 Waste Management of Washington, Inc.

Less than statutory notice request from Waste Management – South Sound for Tariff revisions in Item 230, drop box disposal fees. On January 1, 2025, disposal fees will increase from \$150.83 per ton to \$165.91 per ton plus an additional fixed annual charge of \$37.92 per ton as reflected in Title 10 of the King County Solid Waste Code. This request is to revise Item 230 is a clerical correction of Docket TG-240904, in which the increased disposal fees were approved. The Company serves approximately 17,700 garbage, recycling, and yard waste customers in King County. The Company's last general rate case became effective March 1, 2021.
