Disposition: Commissioner Doumit moved to issue an Order in Docket UT-230144:

1. Designating DISH Wireless L.L.C d/b/a Gen Mobile, as an Eligible Telecommunications Carrier for the purpose of receiving Lifeline support from the federal Universal Service Fund in service areas specified in Attachment 1 and subject to the conditions in Attachment 2; and,

2. Granting exemptions from Washington Administrative Code 480-123-030(1)(d), (f), and (g), which require the filing of a substantive investment plan, wireless network maps, and certification on backup power capabilities1, respectively.

B)1. 10:29 mp4 Docket Number TG-240893; Zippy Disposal Service, Inc.; General rate increase request that, as originally filed, would have generated approximately \$120,000 (6.72 percent) additional annual revenue for the collection of garbage and recycling services. Staff and the company have agreed to a lower additional annual revenue amount of approximately \$111,800 (5.24 percent) resulting in lower revised rates. The Company provides regulated solid waste collection service to approximately 4,480 residential garbage and recycling customers in Chelan, Okanogan, and Douglas Counties. The Company's last general rate increase became effective on March 1, 2023. Tariff Revision

Disposition: The Commissioners took no action, thereby allowing tariff pages filed by Zippy Disposal Service, Inc. in Docket TG-240893 on November 15, 2024, and as revised on January 30, 2025, to become effective February 1, 2025, by operation of law.

B)2. 16:26 mp4 Docket Number TG-240914; Sunrise Disposal, Inc.; General rate increase request that generates approximately \$70,814 (49.8 percent) additional annual revenue for the collection of garbage services. The Company provides regulated solid waste collection service to approximately 205 residential and 114 commercial garbage service customers in Douglas, Grant, Lincoln, and Okanogan Counties. This is the Company's first general rate increase. Tariff Revision
