General rate increase request that, as originally filed, would have generated approximately \$120,000 (6.72 percent) additional annual revenue for the collection of garbage and recycling services. Staff and the company have agreed to a lower additional annual revenue amount of approximately \$113,000 (5.33 percent) resulting in lower revised rates. The Company provides regulated solid waste collection service to approximately 4,480 residential garbage and recycling customers in Chelan, Okanogan, and Douglas Counties. The Company's last general rate increase became effective on March 1, 2023.
